## 097/2019 Essex County Councillors report – ECC Cllr D. Finch

Apologies for not attending many meetings

- Comparison of Councils in the Country, ECC were in the top 10
- Budget Revenue support grant in decline over 5 years. Grants will not be published until January 2020 after the General election.
- ECC at the last Council meeting announced a climate action programme. 127,000 lights in Essex changing to LED lights
- Road maintenance Potholes will be repaired by using 90% of recyclable tarmac.
- 135,000 trees to be planted to combat CO2. Trees can be obtained by the Parish Council. Contact David Finch for more information.
- Battery operate buses will be looked at for the future

## 098/2019 District Councillors report – BDC Cllr I. Parker

- BDC Local plan re-examination section 1 is starting on 14.01.20 lasting for about 2 weeks. Documentation is on the BDC website.
- BDC announced a climate scheme aiming to be a nett zero.
- Refuse trucks to be looked at to cut emission. There is no viable vehicle to substitute existing vehicles.
- Climate action group has been set up. It has become a BDC priority
- Economic growth will be looked at more closely in 2020.
- BDC owns a car park in Braintree and will be developed with a hotel, flats and health and wellbeing centre. Moving bus station to improve the Town Centre.
- Enterprise centre in Witham
- Grant for young entrepreneurs
