Aim.

The aim of the full Review is to: -

- 1. Ascertain the extent and nature of concerns with DWP service delivery locally.
- 2. Seek and encourage the involvement and cooperation of all concerned and to raise awareness.
- 3. Look at the local position to include operation and management of our local Job Centre Plus as being a critical element in a fair and just welfare benefits system. Concerns were raised back in January 2014 re punitive sanctions but it is said that concerns have escalated recently. Why?
- 4. Look at emerging trends. Has Oakley been implemented locally?
- 5. Initiate discussions with our local DWP Manager on ways to resolve or mitigate any issues of concern or apparent service failures.
- 6. Seek the help and cooperation of our MP, Richard Graham, in this review. We are pleased that Richard Graham MP is now on the Parliamentary Select Committee.

Background.

The Forum requested a Review of the operation of the benefits regime particularly with respect to:-

- A) Benefit delays and punitive sanctions.
- B) Operation & Management at our local Job Centre Plus. Is there a gap between policy & practice?
- C) The effect on residents of Gloucester, particular homeless and those with mental health issues.
- D) Health & Wellbeing Board Involvement and the Joint Strategic Needs Assessment.

Interim Executive Summary.

- 1. Major concerns that delays, decisions and system failures by the DWP and our local Job Centre Plus are forcing CHILDREN into extreme food poverty, malnutrition and destitution.
- 2. There is an apparent failure to understand and identify/take account of vulnerable individual's situation. Is there a culture of bullying & harassment, is this endemic?
- 3. Is the above typical of the present work place culture at our JCPlus?

Data/ Evidence.

To be gathered locally from all involved. Service users/customers/clients, Foodbank, CAB, 'Helping Hands', Faith Groups, DWP, Job Centre, Agency's, NHS (re malnutrition, hospital admissions, etc), public and private body's/ charity's, etc.,

Initial investigation of data from the Food Bank, in the following table, has identified some very disturbing trends, hence this interim review. This table covers a period in Aug/Sep15.

There are cases of benefit sanctions for minor offences, which we are concerned often hit vulnerable individuals particularly those with mental health problems or communication barriers. JCP clients have referred to bullying and feelings of fear and anxiety.

Recommendation

That we seek:-

- To encourage dialogue with DWP as to whether this is a local problem, the extent and seek resolutions. Would like to see effectiveness of pilot of the DWP 'yellow card' system.
- An internal JCPlus review of working practices, training, sanctions applied appropriately & fairly.
- Support of relevant agency's, public and private bodies, etc., involved in public health and wellbeing to prevent food poverty and destitution especially when CHILDREN are involved.
- To encourage change of JCPlus organisational culture from any bullying and harassment to one of respect with positive behaviour principles. There is no evidence of the effectiveness that using destitution, stress of being unable to pay rent, etc., helps/ supports individuals into work.
- To make contact with and liaise with CAB.
