The workshop covers recent legal and practice developments in some of the major issues in managing counselling, psychotherapy and coaching work. The course includes report writing, record keeping, confidentiality and client privacy in relation to information sharing between professionals and the courts, duty of care, legal and ethical responsibilities, and much more.

The sessions in the workshop address issues including:

- Update on current relevant law, guidance and ethics
