5) **Highways**

Old Grit Bin, Leer: The Parish Council will arrange for this to be removed.

Manhole Cover at the bottom of Ealy Hill: Repair Ref: 11234925 The side of the cover has been filled with tarmac however the cover still clatters. Highways have requested that Thames Water make additional repairs.

Repairs to the road in Leer: Some potholes have been repaired. Residents can now report potholes directly to Highways on <u>Highways@gloucestershire.gov.uk</u>

Damaged Road Signs at Leer Bridge & Notch Road: Replacements have been ordered and are awaiting installation.

Flooding under A417 Bridges: This flooding occurs because the soakaways fill up with grit and mud, which means they need to be serviced more frequently. Gloucestershire Highways and Highways England are aware of the ongoing issue and are discussing the matter with a view to a possible cost share. Following the Parish Council meeting, Cllr Judd raised the issue with Nigel Robbins at CDC. **Potholes:** Residents can report all potholes to Highways at Highways@gloucestershire.gov.uk
