- 2. The sign in the centre of Abbess Roding was in good condition but required repainting. Clerk to ask Highway Rangers.
- 3. The Clerk reported that the 2021 LHP Pilot contract was in place but the ECC funding had not been received.
- 4. Cllr Markey proposed that the Parish Council purchases small plaques to attach to each post to record that the project was arranged by us. Cllrs resolved that for the time being an information notice would go on the noticeboard. Cllr Lawrance to design.
