# 77/23 Clerk's Report

- 2023 AGAR Certificate of Exemption submitted to external auditor. The period of exercise of public rights has been advertised (website and noticeboard) and expires Friday 14<sup>th</sup> July.
- Green Hill/Anchor Lane pothole reported 2848399.
- Collapsed bridges over the River Roding reported 3457995 (footpath 29) and 3708279 (footpath 21) by a Leaden Roding resident.
- Written to new landowner re large branches preventing verge cutting.
- Clerk to finalise photographic record of Heritage Finger Posts now that the project is finished.

#### 78/23 Police Report

Warren Shepherd (Essex Police Community Policing Team) apologised for being unable to attend the meeting and submitted a written report giving the quarterly crime statistics and stating Operation Brazil was on hold awaiting a Rural Crime meeting.

1. Cllr Milligan had contacted Cllr McIvor to arrange a site visit School Lane, Abbess re collapsed verges. This had not yet been held. Cllr Balcombe suggested Highway Rangers could deal with the overgrown vegetation. There was also the problem of silting.

2. Cllrs reported temporary repairs to potholes but ones nearby had been left. Clerk to report pothole at the triangle at the bottom of Poplars Hill.

#### 80/23 Local Highways Panel LEPP222041

Improvements at junction Berwick Lane/B184 Nether Street.

Cllr Balcombe passed this to Cllr Ian Hadley who is on the LHP. Acknowledged that sign is faded. LHP has asked Cllr McIvor, who is also on the panel, to support this.

Response for funding request from Cllr McIvor.

He cannot fund signs which could be provided by ECC. This would be through a LHP Scheme. Cllrs commented that a replacement sign was request at Hales Farm but this was never done.
 He could fund a sign similar to that at Fyfield. Cllrs commented that Abbess Roding already had a village sign but this was not what was required for the Parish as opposed the villages.
