E28/20 Chairman's Welcome

E30/20 Approval of Minutes

Cllrs resolved to agree the minutes of the planning meeting February 27<sup>th</sup> 2020 and meeting January 22<sup>nd</sup> 2020. The Chairman will sign at a later date.

E31/20 Declaration of interest in Agenda Items

Cllr Metson declared a non-pecuniary interest in the Berwick Hall planning application.

E33/20 Clir Mrs M McEwen EFDC & ECC.

The Clerk continued to liaise with Cllr McEwen during lockdown. Cllr McEwen had requested more information for the Local Highways Panel Meeting on July 11<sup>th</sup>.

## E35/20 Heritage Finger Posts – Local Highways Devolution Pilot

- 1. Cllr Stratton reported that he is waiting for prices on the timber to go ahead with the next stage of the work.
- 2. Cllr Stratton was arranging to stabilise the base of the Poplars Hill post which was leaning.

# E36/20 Berners Roding Kiosk

Insurance pay out agreed and replacement door ordered. The Parish Council resolved to thank Keith Daly of Essex Farms for agreeing to fit the door.

### E37/20 Berners Roding Defibrillator

- 1. Fully funded through Cllr McEwen's ECC Locality Fund. Cllrs had approved the purchase and ongoing costs. The cabinet has been delivered but awaiting the defibrillator. Mr Jim Lander of Ace Security and Electrical Ltd has generously agreed to connect the electrics in return for a donation to Rodings Dream Team who are continuing to make scrubs, etc for the NHS and care homes.
- 2. Cllrs to note London Hearts will supply training.
