22/22 Chairman's Welcome

23/22 Apologies for absence

None.

24/22 Approval of Minutes

Cllrs agreed minutes of the meeting January 19th 2022 as a correct record. The Chairman signed for the records.

25/22 Declarations of interest in Agenda Items

Cllr Markey declared a pecuniary interest in planning EPF/0023/22.

26/22 Public Representation

The member of the public explained the background to reported defect 35352083. The flooding was causing damage and a danger to traffic when icy. His landlord had attended the APM and the Clerk had escalated the issue to Cllrs Balcombe, McIvor and Scott. Cllr McIvor agreed to visit the Area.

27/22 Police Report

The Parish Council expressed its thanks to PC Shepherd for attending the meeting. He had obtained a breakdown of the crime figures for this Parish.

28/22 District Councillor Report

Cllr Balcombe spoke about the granting of planning permission adjacent to Brook Cottage, Abbess Roding. No further action could be taken but the permission conditions should minimise disruption.

29/22 County Councillor Report

The Parish Council welcomed Cllr McIvor to his first meeting. He asked that all escalation of Highways reports should be made through him. The new administration was changing its priorities. He outlined the change in approach to repairs in that if a team was sent to repair a pothole it was encouraged to fill other potholes nearby. There were more funds available at a local level through the Local Highways Partnership and more attention given to rural issues.

30/22 Clerk's Report

The Clerk said she was disappointed with the Report It system. Defects disappeared from the system which was not user friendly.

31/22 Matters Arising from the Annual Parish Meeting

Rural Affordable Housing

Cllrs thought that RCCE Laura Atkinson's presentation at the APM was impressive but were still reluctant to take this forward due to the experience with Bass Cottages. Cllrs resolved to look into the costs, Cllr involvement and time scale before committing.

32/22 Highways

1. Fly Tipping

Cllr Holly Whitbread arranged for the Environmental Enforcement Officer for the Community Safety Team to put up No Fly Tipping Signs at either end of Anchor Lane. She will put up more signs, in particular hotspots if required and follow up with cameras. The more cases are reported the more this area will be prioritised. Cllrs had not noticed the signs but though incidences had reduced.

- 2. Berwick Lane/B184 junction at Nether Street poor visibility splays. Cllr Markey. Due to the road layout the only options appeared to be signage and a mirror.
- 3. Flooding on B184 multiple locations

Cllr McIvor advised there a lot of high-level work going on but this was more concerned with alleviating flooding to properties. East of England Flooding Disaster Emergency Planning.

4. Berwick Lane (Abbess Roding end)

Multiple defects have been reported with potholes and road edge erosion. Cllr McIvor.

- 5. Falkiners, Abbess Roding **defect 35352083** (previously 2696364). See 26/22.
- 6. Black Poplar Trees

Cllr Milligan. Trimmed by UK Power Networks. Reported to ECC as defect 2764989 (previously 2670070).

- 7. Three Hurdles, Beauchamp Roding road surface **defects 3622401 & 3489654** Reported by resident who escalated to Cllr Balcombe. Cllr McIvor.
- 8. Cockerills pothole reported for Cllr Lawrance **defect 2760249** (previously 2715763). This pothole is now huge.

33/22 Defibrillator

1. Berners Roding

Cllrs agreed that the Clerk could order replacement pads (for June).

2. Abbess Roding

Central Rodings Primary School have allocated ring-fenced funds £1,619.27. Cllrs agreed it should be sited in the centre of Abbess Roding. The Church has given permission to put it outside (Cllr Parmenter). Cllr Osborne to ask Mr Osborne about siting on farm building. Cost would be depend on power source (mains or solar) and whether it needed a heated cabinet.

34/22 Heritage Finger Posts

- 1. Cllr Stratton will liaise with Cllr Lawrance on information notice.
- 2. Cost of the project to date £4,100 (excluding Abbess Centre, Two Swans and contractor's final invoice).

35/22 Boundary Markers Parish Project

Cllrs to discuss style of markers and costings. Cllrs thought (polo) finials or roundels on top of the finger posts would be a good alternative. Clerk to ask Fyfield PC about their blacksmith.
