#### 24/23 Apologies for absence

Cllr I Milligan (ill health).

#### 25/23 Approval of Minutes

Cllrs agreed minutes of the meeting January 11th 2023 as a correct record. The Chairman signed for the records.

# 28/23 Police Rural Burglary Reduction Scheme

Warren Shepherd outlined the new initiative and how the Parish Council could support it. It was aimed at residents who had large amounts of plant and machinery rather than ordinary householders. EFDC would buy the security marking kits with signage. A targeted leaflet drop would offer the kits at between £20 and £28 which would mark up to 50 items. Awareness of the marking would reduce theft and assist recovery if the item was stolen. The Parish Council resolved to support the initiative.

## 29/23 District Council Report

Cllr Balcombe reported on the following items -

- 1. Tina Cooper has been appointed Police District Commander (based at Loughton).
- 2. The Boundary Review was almost finalised and would be in place from 2024.
- 3. The rubbish collections seemed to have improved. There will be changes to the recycling.

## 30/23 Clerk's Report

- 1. Special Roadside Verges at Berners Roding. No response from Saffron Walden Museum or Essex County Council.
- 2. Reported collapsed verges in School Lane, Abbess Roding 270762 and 270764. Reply from ECC reports "assessed and monitored by routine safety inspections" but does not say what.
- 3. Thames Water incidents. Replied to resident re exceptional discharges in October 2022. Now seems to be occasional. Will keep under review.
- 4. Willingale Clerk has details of our fingerpost project. Cllr Stratton attended their meeting.

#### 31/23 Highways

- 1. Cllr Milligan would like to arrange a meeting with Cllr McIvor re verges in School Lane, Abbess.
- 2. Work at Three Bridges to remove silt and prevent flooding has had little effect.
- 3. Cllrs resolved to ask for improved signage at the junction of B184 and Berwick Lane at Nether Street through LHP Scheme.

## 32/23 Heritage Finger Posts

Cllr Stratton reported that a replacement letter "V" for sign in the centre of Abbess. The contractor will submit the final invoice very soon.

Cllrs approved the Arien Design signs for Abbess and Beauchamp and asked for the quote to include Berners as Cllr McIvor had agreed to fund.
