Inspector Jonathon Main had spoken to PC Shepherd about speeding on the B184 and was happy to attend Parish Council meetings.

The Speedwatch Scheme was discussed but as the volunteers can only operate in a 30mph zone it was not thought to be appropriate to this Parish.

The Clerk continued to be frustrated by the ECC Highways Report It Scheme. She only received notification that a defect had been inspected if she sent the request. It was the necessary to find the location on the map to see what it was and the outcome. It was obvious that the same issue was being reported several times and it was a concern that ECC did not seem to realise this on inspection.

The Clerk gave Cllr Stratton details of how the level of the defibrillator battery could be assessed as requiring replacement.
