#### 1. Covid-19

- 1. I am receiving daily emails. Unless they contain new and relevant information I will not forward them to you.
- 2. The position with urgent decisions remains that they can be dealt with by email either by the Clerk with the Chairman and Vice-Chairman or with a majority.
- 3. The Parish Council has decided against setting up remote meetings. I suggest this is reviewed if the lockdown is not relaxed.

## 2. Accounts y/e 31/3/2020

The legislation has been amended.

- 1. I have completed all the paperwork and have sent it to the internal auditor.
- 2. The Parish Council is exempt from external audit. The exemption form has to be with PKF Littlejohn by 31 July 2020. This requires a "wet" signature.
- 3. Everything must be published between 30 September and 30 November.
