Can this be addressed and removed? **Highways** Parish Clerk vacancy - update The Clerk informed the meeting that 2 people have applied for the vacancy and an interview date will set up after this meeting. **ARG Report – Colin Cooper** By the time this report is formally presented to the PC Meeting, we will have had a Spring Litter Pick organised by ARG and local resident and Southminster Parish Councillor Adrian Fluker. An oral feedback report will be presented to the PC on the night. ARG has arranged for the long outstanding project to clear the ground ivy on the land opposite Sandlings. This will be on the morning of Saturday 12th April (time to be announced nearer the date) ARG member Graham Chandler of 2 The Orchards, Hall Road and myself did make an attempt at clearing the ivy the other day. Graham taking along his rotary push mower and a strimmer fitted with a spinning metal disc. However, as Graham's mower was in danger of being damaged by the numerous hidden wooden stumps of bushes concealed by the ground ivy, the project was abandoned after a short while. A&D Parish Cllr. Andrew Snowdon, even though of course not an Asheldham resident, has kindly volunteered to take along on the 12th a more heavy-duty machine which he believes will cut off the presently concealed stumps and anything else above soil level. If successful then future moving by ARG between the larger stumps should be possible. The moving contractors have said they cannot do this with their very large mower. A date has still to be set for sapling planting at Silver Lake. Mrs. Joanne Griffiths our local tree warden has replaced the tree which she planted last year near

the bridle path as it died. The other tree she planted on the green near the Village Sign has flourished. Both trees had generously been paid for by the PC. Joanne has paid for the

048/2025 British Solar Renewables - Dengie Solar Park

The Parish Council discussions concluded that there are concerns over the speed of delivery vehicles on Hall Road and Keelings Road, with residents making complaint. Debris on the road has been reported in proximity to the site entrance, and it is felt that the horse warning signs would benefit from being moved. The signs are currently placed in the same location as Essex Highways warning signs. It is felt that one sign should be moved to approx. 150m West of the Green Lane / Southminster Road junction. This would serve warning to drivers heading to the site of the horse risk at the end of the bridleway on Green Lane. Concerns were also raised regarding the lack of response to the issue of the promised Community Funding.

It is proposed that the Parish Council write to BSR Ltd raising these concerns, with copies to the head office and to the site manager, and that Cllr Snowdon will take a copy to the site in person and discuss matters with the site manager

25/00163/HOUSE - Three Oaks Southminster Road Asheldham Southminster

Proposal: Erection of single storey detached garage.

RESOLVED: The Parish Council objects to the application on the grounds of potential sensitive archaeology within this site.

We are also concerned by the prominent visual impact the proposed building would have. The view from the road would present a solid brick wall in place of the existing open view of the rural landscape. It is considered that this would be far less intrusive if the north facing wall was of weatherboard, in keeping with small rural farm buildings.

The consent for the existing dwelling was supported by the Parish Council because the residence sat on an existing building footprint (the old water tower) and was totally screened by existing building to the north. It would be more sympathetic to the rural scene if the applicant was to propose the garage be built to the East of the dwelling.
