	O67/2025 Questions from the Press and Public – (This session will not exceed 15 minutes – unless otherwise directed by the Chair - no individual to speak for longer than 3 minutes on any one issue) An opportunity for members of the public and press to speak about items on the agenda and to raise other issues. A resident questioned if the planning application ESS/36/25/MAL/SPO was part of the existing approved application. Cllr R. Griffiths advised that the application was part of the existing timeline but not part of the approved application. The resident commented that the applicant is trying to squeeze more planning applications in, over and above the approved extraction which has already been approved. He was expecting the project to be finished and put back to its original state as per the original application and the area is going to be compromised in some form or another and imagine that they will be able to just roll on if this application is allowed to proceed. The resident asked how does the area benefit from these extensions. He also just sees that it will mean an increase in extra heavy goods vehicles. Another resident commented that they thought that the applicants were ahead of schedule and the extension would be completed before 2029 but just sees that the applicant is now using that time to increase the extension. They further commented that, if they knew that the heavy traffic would come to an end in 2029 you could deal with the situation, but it would be unbearable to live in Asheldham if the heavy vehicles passing through the village continued for another 15 years. The vehicles are getting increasingly larger. A resident commented that the local highways are just not suitable or safe for the heavy lorries and you can see by the condition of the roads that it is taking its toll. Cllr W. Stamp asked would the residents like her to comment against the application as the Essex County Councillor. Cllr W. 070/2025 Village Hall Report – Lyn Moull

071/2025 Locality Funding – Cllr S. Russell

Cllr W. Stamp advised that she has a locality fund meeting on Wednesday 14th May and suggested writing to her with a proposal once she advises the amount awarded.

072/2025 Dengie Marshes Wind Farm Project

Cllr A. Snowdon advised that the next date for the consultation is very close before the planning proposal is submitted. It is feared that Asheldham will be used as a route to bring in the heavy aggregate and would advise that transport by sea would be far suitable option.

Cllr A. Snowdon reported that residents are placing their homes up for sale due to the proposed project.

Cllr W. Stamp suggested attending the consultation and find out about community benefits. Cllr W. Stamp has asked them if a bus service could be considered for funding by the project. She also added that there is a wildlife concern.

Cllr A. Snowdon suggested that a public consultation could be held at Dengie Village Hall.

073/2025 British Solar Renewables - Dengie Solar Park

Cllr R. Griffiths advised that she had not received a response from her application for funding and will continue to chase.

Cllr A. Snowdon reported that a response had been received from BSR Limited to the letter compiled by Cllr. A Snowdon and sent by the Clerk. Cllr A. Snowdon will still visit the site and introduce himself to the site manager on behalf of the parish council.

Cllr R. Griffiths added that BSR Limited had confirmed that they can provide additional signage.

Cllr A. Snowdon confirmed that BSR Limited will need to apply for permission from Highways to move the location of the signs and that the signs need to be within 20 yards of the existing signs. Therefore, suggested that one sign is placed near to the bridleway.

Cllr W. Stamp asked if BSR Limited had supplied signs.

Cllr A. Snowdon advised that they did provide the signs but that the signs were placed directly near the existing Caution Horses, Pedestrians and No Footpath signage already installed.

Cllr W. Stamp advised that she could contact Highways if the Parish Council wishes her to.

1) MDC Planning department – Cllr A. Snowden

Cllr A. Snowdon raised concerns that the decisions regarding recent planning applications was incorrect and a letter is required to be written to Maldon District Council planning department to ask for the reasoning behind the decision and how a conclusion was made that the building was still agricultural when the site had existing permission for equestrian use.

Cllr W. Stamp asked what did the officers report said. Cllr A. Snowdon advised that the report stated that the application was approved under Schedule Q, although there were numerous local objections against the application and that the site had not been used as agricultural and clearly has equestrian facilities.

Cllr W. Stamp suggested contacting District Councillor Matthew Neall and ask him to arrange a Teams meeting with the planning officer who made the recommendation for explanations of the decision.

RESOLVED: The Clerk will contact District Councillor Matthew Neall and request that a Teams meeting is arranged. **Agreed. Unanimous decision.**

A resident asked, thinking about the future, what the parish councils' position would be on the possible next phase of extension to Asheldham Quarry.

Cllr R. Griffiths explained that a full response was submitted at the time of the consultation and the councillors objected to the inclusion in the Essex mineral plans. And as far as Cllr R. Griffiths is aware, the application is still in the review stage and the final strategy has not been published. Once the strategy has been published, the parish council will then know if the Asheldham site has been included in the future mineral plan. However, we are long way off from any potential development of that site as, even if the site is included in the Essex Mineral Plan, a viability of the site will be required to be carried out.

Cllr A. Snowdon advised that the grounds for Asheldham and Dengie Parish Council's objection to the previous application was the excessive amount of traffic continuing beyond the extraction deadline.

Cllr R. Griffiths advised that the planning will be considered as and when the application is submitted.
