i) Clerk read out the reason that the 40mph limit was refused...a discussion was had with the engineering and policy teams with regards to the possibility of reducing the speed limit through this section. Unfortunately it is not felt that at this time that this section of road would comply with Essex Speed Management Strategy for a

- reduction in speed. The environment is them or determining factor in speed choice, so drivers should expect to see the same limits in similar environments. Signing alone in environments of this nature is unlikely to achieve compliance. They provided an extract from the strategy which states the criteria that a 40mph speed limit would be considered. Item to be taken off the agenda.
- ii) Clerk stated that a meeting has been set for Friday 9th July 10.30 to 11.30in Dengie Village Hall to meeting Cllr Scott to discuss highways matters and everyone is welcome to attend. Please let Clerk know if you are attending so numbers can be watched.
- iii) Clerk has sent in the project to the Local Highways Panel and copied to Cllr Wendy Stamp and this is expected to be reviewed at the next LHP meeting on 10th September. This is to request the Engineers to look at the Asheldham Bends project first started in 2014 and asked to look at the 3 bends, but stopping just after.
- iv) A resident had read the report and said the report was fairly comprehensive. Reflectors have been requested and a temporary weight restriction, the white road markings indicating a narrowing, but did not meet the criteria. Cllr Russell raised the concern about the huge crack under the bridge and the level of the water would be higher in Oct/Nov when it is presumed that the water level would be high. Clerk to make a note.

It was also mentioned that if it went at the top of Manor Road only one side of the double sided sign would be seen. Other spots were mentioned but reasons came as to why it would not be possible. Planning permission will be required whatever site it is installed. Clerk to research all possibilities and bring back for discussion and decision. Clerk confirmed that a ECC Licence was obtained for the Asheldham sign.
