Reasons being proven nuisance to neighbours, hence the serious enforcement actions taken thus far. Very concerned that the applicants report is at odds with information in the public domain and that the business has sought to advertise and continue during the enforcement / application process.

23/00244/FULM - Land To The South Of Keelings Road Dengie Essex

Erection of a 19 MW Solar PV Array, comprising ground mounted solar PV panels, with co-located 5 MW battery energy storage system (BESS), vehicular access from Keelings Road, internal access tracks, landscaping and associated infrastructure including security fencing, CCTV cameras, and grid connection infrastructure including transformers, substation compound buildings and cabling route to the point of connection

RESOLVED: Refuse this application

The Parish Council is fully aware of the need for renewable energy, however the applicant has failed to answer properly questions raised in the Public Consultation, and the application falls far short of the details required to make a proper decision.

Having considered the application carefully, and planning guidance issued on this topic elsewhere in the country, we are concerned at the lack of information regarding construction method and noise mitigation. Proper detailed assessment of the impact of the structures within the site over the long term (effects of rain drip, large quantites of galvanised material in soil contact. A total lack of clarity on vegetation control in and around the panels, with dubious land management in the surrounding area. Gross errors on the fencing plan information and poor construction. A lack of information on the provision of water to newly planted trees (approx. 5cubic meters of water every 14 days). There is no provision for any workers on site during maintenance work in terms of wash room and toilet facilities. There is no statement on the methodology for soil management during construction or for the reinstatement at the end of the 40 year lease. Maldon already has significant renewables projects, the Dengie in particular hosting a very significant amount of wind and solar already. By the nature of the construction, this facility has foundations, and as such cannot be regarded as a temporary structure any more than one would consider many an agricultural building temporary. Part of the proposal whilst not directly a planning matter, but part of the application as such is the Community Funding, which by comparison to payment levels elsewhere for both wind and solar is derisory in extreme.

The Parish Council urges MDC to refuse this application given the amount of information lacking therein.

- f) Where a person ceases to be qualified, or becomes disqualified for any reason other than conviction or order, or is persistently absent from meetings, upon the date when the office is declared vacant by the High Court or council as the case may be.

- d) I have, during the whole twelve months, resided in the parish, or within 3 miles of it.
 - 2. Please note that under Section 80 of the Local Government Act 1972, a person is disqualified from being elected as a Local Councillor or being a member of a Local Council if he/she:
 - a) Holds any paid office or employment of the local council (other than the office of Chairman) or of a joint committee on which the Council is represented or
 - b) Is a person who has been adjudged bankrupt or has made a composition or arrangement with his/her creditors (but see below) or
 - c) Has within five years before the day of election, or since his/her election, been convicted in the UK, Channel Islands or Isle of Man of any offence and has been sentenced to imprisonment (whether suspended or not) for not less than three months without the option of a fine or
- d) Is otherwise disqualified under Part III of the Representation of the People Act 1983 for corrupt or illegal practices. This disqualification for bankruptcy ceases in the following circumstances: i. If the bankruptcy is annulled on the grounds that either the person ought not to have been adjudged bankrupt or that his/her debts have been fully discharged; ii. If the person is discharged with a certificate that the bankruptcy was caused by misfortune without misconduct on his/her part iii. If the person is discharged without such a certificate. In (i) and (ii) above, the disqualification ceases on
