20-21/034 - HIGHWAYS & PUBLIC FOOTPATH ISSUES

- i) Clerk emailed Thomas Eng concerning the email received.
- Propose that we go back to him and loop in Cllr Kevin Bentley and say that there are extenuating problems in Asheldham because you have one of the largest active quarries and largest crop company that impact on everything. Member believes that the Essex Highways Strategy does not extend to Southminster Road, Asheldham. Against all the odds 20mph speed limit in Maldon that has been put in, albeit due to Covid-19 is being requested to stay due to the improvement in air quality. Need to keep the pressure on. Write to the local companies as well.
- ii) Update regarding requesting the Local Highways Panel for a reduction in the speed limit to 40mph on the Tillingham Road (Dengie Straight) from Reddings Lane and clerk to write to residents along the Dengie Straight for support to reduce the speed limit to 40mph which will hopefully give more credence to the LHP request.
