20-21/106 – QUESTIONS FROM THE PRESS AND PUBLIC – FIRST SESSION

- Resident stated that he would wait for the second session for some items, however noted
 that the work on the Asheldham Brook Bridge had started. No foliage has been touched on
 the brickwork, seemed to have lopped some trees down on the Western side coming from
 Southminster.
- Resident raised the question as to why in regard to the planning application there are 5 caravans on the site and requested that the members give this some thought. Clerk mentioned that the question has been raised with Enforcement. Another resident stated that it had been stated in the past that one caravan for one property. Clerk is following up with Enforcement in this regard.

20-21/107 - HIGHWAYS & PUBLIC FOOTPATH ISSUES

- i) The application has been sent to CC Ron Pratt to get him to sign off the LHP application regarding the request for a 40mph to be implemented along the Dengie Straight Tillingham Road, from Reddings Lane T-junction.
- ii) An email has been received from Cllr Brown stating that she has tried to call Alfie Hunter requesting an update and Clerk received email stating closure will now be 4th to 12th January 2021 and confusion was raised about actually where the roadworks are actually taking place. It was considered it could be the kerbing, but Clerk has sent email asking for clarification.
- iii) No news from ECC regarding the state of the pavement from Rushes Lane to Bend opposite the "The Rest".

iv) The application has also been sent to CC Ron Pratt and when received back will forward to the Local Highways Panel for them to consider installation of a pavement from opposite the entrance to Brooks Lane to join with the current pavement around the bund.

v) No information received from PROW regarding the PROW244 10. Clerk will chase.

20-21-108 PROBLEMS ON PARISH COUNCIL LAND

I) Clerk has looked for plans but can not find, so will speak to previous clerk but had already sent a boundary request from the ECC Record Section and waiting for that to come through and will aid with where the sign that Cllr Brown would like can be placed.

No news on temporary sleepers, Mr. Faulkner will be visiting Asheldham soon and will have a look. Clerk spoke to MSJ Garwood the grass contractor and they said they will manage around anything that is placed there.
