70/23 Chairman's Welcome

Cllr Reynolds welcomed those present.

71/23 Apologies (and reasons) for absence

Cllrs resolved to agree minutes of the previous Parish Council meeting May 15th 2023. Signed by Chairman.

76/23 CIIr S Barker UDC and ECC Report

1. The Local Plan will go out for consultation at the end of October 2023. The housing requirement is 700 per annum. This includes past developments. There are currently four times more sites than required. This includes 1,200 at Leaden Roding.

2. Grants are available for energy saving measures, such as solar panels, on community buildings.

3. Ride London is confirmed until 2026. Any questions or comments should be addressed to Ride London.

4. Concern that lorries are not using commercial sat nav resulting in use of unsuitable routes. Cllr Woodmore asked about the Bushcade lorries travelling on the B184*.

*Cllr Barker reported post meeting that the lorries moving topsoil from Braintree to Fyfield – completed.

5. Cllr Barker confirmed there was no Highways Rangers provision in Uttlesford. Cllr Woodmore said he would report* the annual problem of overhanging vegetation on the footway from Westpoint to Leaden Roding.

*Post meeting Cllr Woodmore confirmed already shown as reported.

- Aythorpe Roding Community Hub Written report. Cllr Reynolds had attended the AGM.
- Cricket Club
 Cllr Reynolds reported that despite the team being bottom of the league the energy of the Club was good but it needed more quality players.
- Inspection of assets Written report.
 Cllr Coward Whittaker confirmed the new defibrillator pads had been fitted and the unit was working. Clerk had put back online.

78/23 Clerk's Report

- 1. Remus as management company for Old Mill Close requested Parish Council to act on water in ditch at entrance to development. Clerk advised that PC not responsible and the ditch has subsequently been cleared. Cllr Woodmore reported that a resident was now on the Management Committee. The lighting issue was ongoing.
- 2. Verge contractor asked to cut Roundbush Green.

79/23 Highways

Cllr Lander reported on her meeting with Cllr Lee Scott (ECC Cabinet Member for Highways Maintenance and Sustainable Transport) and Kemi Badenoch MP. Points to note -.

- Essex roads speed review will result in changes.
- Possible introduction of "True Cam" hand held cameras with Police training and ability to fine speeding motorists.
- Aythorpe Roding speed limits.
- Nomination of "dangerous" potholes
- High Roding road surface is noise reducing.
- Highways Rangers work now being dealt with in house.
- DigiGo bus service to be rolled out across Essex

- Footpath Scheme to clear footpaths
- Cllr Scott will attend PC meetings to discuss Highways. Several Parishes to join together for meeting.
