19/21 Chairman's Welcome

Cllr Reynolds welcomed those present.

- 20/21 Apologies None.
- 21/21 Approval of Minutes Cllrs resolved to agree minutes of the previous meeting January 11th 2021 as a correct record. Chairman to sign in due course.
- **22/21 Members Declaration of interests in Agenda Items** Cllr Coward Whittaker declared a non pecuniary interest in Item 14.1 Drury Lane ditch.
- 23/21 Public Representation None.
- **24/21 Resolution for Council to exclude members of the public and press** None.
- **25/21** Clir S Barker UDC and ECC Report Unable to attend due to emergency. She continues to liaise with the Clerk.

26/21 Reports

1. Cllr Lister reported that he had not heard from the Village Hall in response to his email.

2. Cllr Reynolds reported that the Cricket Club would not now merge with High Roding CC. Cllrs to note that the Bill Reeve Pavilion has had its electrical inspection and the work carried out.

3. Cllr Coward-Whittaker reported the condition of all assets was satisfactory. He agreed to undertake the monthly visual inspection and a quarterly check of the Defibrillator. Clerk to send inspection requirements.

27/21 Clerk's Report

1. Liaison with High Roding Parish Council after road closure and damage to minor roads from diversion. Parish Inspection to record and report highways issues.

2705309 near to Loves Farm - deep ruts/damage to protected verge 2705313 near to The White House - severe damage to verge

2. Contact with named person at UDC regarding B184 fly tipping. Black bags now thought to contain garden rubbish.

3. Precept demanded.

4. Permission given to Allotment holder plot 7 for fruit cages and low fence. There is now a waiting list.

5. Contact with Gigaclear re rubbish and verge damage.

28/21 Highways

1. Cllr Woodmore reported that he had received positive replies from Essex Police on the speeding and noisy motorcycles (Adam Pipe Head of Roads Policing and Steve Parish of the Roads Policing Unit). They were aware of the issues and would send out patrols when possible. He was alerted to Community Speedwatch. Cllrs will consider if this is something the Parish Council should organise. He had not heard from High Roding PC.

2. Cllrs were concerned about the damage to verges on the side roads throughout the Parish.

29/21 Planning

New application

UTT/21/0067/FUL West Point, Dunmow Road.

Proposed erection of 1 no. dwelling, creation of new vehicular access (existing access will change to pedestrian) and associated landscaping works. Comments.

UTT/20/3091/FUL The White House CM6 1PD Change of use from agricultural to extended domestic garden. Approved with conditions.

UTT/21/0758/HHF The White House CM6 1PD

Proposed single storey extension.

Cllrs noted that the block plan did not included the recently built cart lodge. There were still concerns over lighting and whether the cart lodge was permitted development. Comments to Clerk by March 12th.

31/21 Litter Pick

Cllr Woodmore has moved the date to April 17th to allow for further reductions in Covid restrictions. This will be advertised in Ten Parish News and on the Noticeboard.

32/21 Correspondence

A resident of Drury Lane has asked the Parish Council to clear the ditch between the property and the Recreation Ground to reduce flooding. The Clerk has sent a link to the ECC Watercourse Maintenance leaflet and advised the residents that other flooding issues, are a private matter between them and the land owner(s).

Cllrs agreed that there had been an exceptional amount of rain over the winter. The opinion was that any problems were due to the ditch water not flowing away. Cllrs resolved to obtain quotes to remove debris from the ditch. The legal position is that the land owners on both sides of the ditch are both responsible for maintenance so the resident would be asked to agree to contribute to the work. Cllr Reynolds to seek quotes.

33/21 Information exchange/next agenda items only

1. Damage to verge at New House Farm due to building work. Discussion of whether there is a requirement to undertake remedial work. Clerk to research.
