1. Local Highways Panel

The Clerk reported on her site meeting with Cllr Barker and Rissa Long (LHP Liaison Officer). The various speed options were discussed and unlikely to be approved within current guidance. No speed bumps. Other calming measures such as reviewing current speed repeater signs, chevrons and "illusion" or "ghost" signs were possible.

Cllrs had been given details of the various options and resolved that the other calming measures should be requested. No options requiring street lighting would be proposed.

Clerk to submit amendments to previous scheme rather than a new scheme as agreed with Ms Long. New Schemes close November 22nd.
