# 83/22 Approval of Minutes

Cllrs resolved to agree minutes of the previous Parish Council meeting July 11th 2022.

## 84/22 Members Declaration of interests in Agenda Items

## 85/22 Public Representation

## 86/22 Cllr S Barker UDC and ECC Report

- 1. Funding available for potholes. Suitable potholes to be advised by Cllrs.
- 2. Cllr Barker had funds available from Uttlesford and Essex. The ECC was particularly for "green projects".

- 3. RideLondon was confirmed for May 28<sup>th</sup> 2023 (one day only). The route would be announced in October. There would be shorter road closures, better signage and more help for businesses to remain open.
- 4. The Local Plan continued to be deferred. The site for 3K houses in Saffron Walden was not proceeding. The sites for 17K had not yet been made public.

# 87/22 Reports and updates

1. Community Hub (formerly Village Hall)
Cllr Lister read the report from Niki Scripps (Secretary) with positive news on the bookings and, future events. Clerk to thank Niki for report.

#### 2. Cricket Club

Cllr Woodmore reported that The Club had won the last league game and would not be relegated.

3. Inspection of assets

Cllr Coward Whittaker reported that assets were in order.

4. Defibrillator Training

Cllr Lander reported on the training organised by Leaden Roding PC. She thought it would be useful for a training event to be held in the Village Hall. Clerk to ask Village Hall to display defib poster. Clerk displays defib poster on PC noticeboard as space allows.

#### 83/22 Clerk's Report

- 1. The Clerk had asked the Contractor to carry out a cut of Roundbush Green. He was reluctant to do so in the drought conditions as the machinery could cause a spark and fire. Cllrs reported that a cut had started that day but appeared to be unfinished. Clerk to contact Contractor.
- 2. The Clerk had received notification of a defibrillator software update but no further action to be taken as it had only just been returned.

## 84/22 Highways

- 1. Cllr Lander had reported the overgrown footway from Gunners Green to the Axe and Compasses. Clerk reported to Highways Rangers.
- 2. Potholes to be notified to Cllr Barker,
  - a. Length of School Lane as far as Bigods particularly outside Aythorpe Manor.
  - b. Road to Keeres Farm which is Highways land.
