2. Welcome from the chairman and executive committee.

ML welcomed everyone on behalf of the Executive Committee and introduced Neil Jones as the guest speaker.

3. Meeting topic and guest speaker: Neil Jones, Senior Planner, Braintree District Council. A presentation about \$106 agreements

NJ talked through his presentation about S106 and advised that they are legally binding agreements between the developer and the local authority which sets out planning obligations as defined in Town and Country Planning Act.

The following questions are answers were given:

Q – Where do Councils fit in with the process if the developer tries to engage with them.

A – Developers should speak to the Parish Council as early as possible, and Parish Councils should engage with the BDC planning officers and ensure the Open Spaces Action Plan is up to date with a range of projects.

Q – Are any funds available for parishes were the surrounding areas outside the parish get developed and are affected by those developments

A – No S106 money is available for the villages where no developments are carried out. NPPF states that where the development negatively impacts the highways network, this may be considered but only if the impact is severe. The severity is difficult to quantify.

Q – Why do Parish Councils have to have wish list before the planning application is put in? A – That is the current process for S106

Q – There is a huge difference between the £1.9M funds received by BDC from the Infrastructure Statement and the £221000 BDC have so far spent. What is the reason for this?

A – This is a BDC resource issue. BDC are working on the consistency and communication and there are some larger projects where money is being pooled, for example to build a community building.

Q – The legal agreements specify how the S106 money is spent so why cannot Councils get the quotes and have the money

A – This is should happen and is the correct process. BDC do chase the developers. Contributions are linked to development and are index linked.

Q – How much do BDC hold in S106 money

A – NJ will advise the clerk

Q – Can the Open Spaces agreement be updated at any time?

A – The update is once per year, but new projects can be submitted at any time.

Q – What happens if the landowner changes?

A – BDC will contact the new landowners to ensure the existing agreement is understood

ML advised his Council received a big rates refund by asking BDC to check the charges. PL said he felt that the ECC Devolution Project was a lot of work for a little reward. It was generally agreed that the scheme was unworkable due to the bureaucracy and limitations imposed.
