Serious Violence Unit established July 2020 -67 officers • Investment in 30 officers and better technology in 2021-2022 precept • April – June 2022, the Serious Organised Crime Unit within SCD dismantled OCG recovered18 viable firearms with ammunition • SOC seized 19kg of cocaine and arrested a number of significant OCG nominals, • Recovered £38,000 and receiving a proceeds of crime forfeiture of over £800,000. • Essex police have recorded 53 OCG disruptions in April and May this year, making Essex the lead force for OCG disruptions in the Eastern Region.

Protecting vulnerable people and breaking the cycle of domestic abuse

Reducing violence against women and girls

Offending Essex experienced a 6.2% increase (2,315 more) in the number of VAP offences committed against females in the 12 months to August 2022 compared to the 12 months to August 2021; this compares to an 8.6% increase (2,435 more) in the number of VAP offences committed against males in the same period.

HAVE YOUR SAY on paying for policing and fire and rescue services in Essex

The Police, Fire and Crime Commissioner for Essex (PFCC), Roger Hirst, is seeking views on paying for policing and fire rescue services in Essex, as he sets the 2023/2024 budgets for the Services. Funding for Essex Police comes from two sources, central government funding and local council tax, while funding for Essex County Fire and Rescue Service (ECFRS) comes from central government, local council tax and business rates.

Essex residents are being urged to have their say on how much they would be prepared to spend and which areas of policing and crime they would like to see further investment in. They can fill in a survey to give their views.

Following his presentation, he took questions from members

Kelvedon PC asked about speeding, drinking and drug abuse. Gangs walking in high street with knives at 6pm in the evening. What can be done? Roger responded by passing this onto Police department but to get residents to report these offences and Crimestoppers or 101. The more reporting is better than none. Jane Gardener said she would email the appropriate person and request contact is made with the Kelvedon PC to investigate the matter.

Martin Lee – 900 extra officers only went back to 10 year ago levels. Roger Hirst said that more officers are being trained. Increasing the numbers by 10%. 250 Officers leave each year. More

efficiencies are important. With the Fire Service possibly going on strike leaving the experienced officers at a low level. Fire-fighters are leaving and not being fully replaced.

Jane mentioned that police officer numbers are rising. New officers are placed on front line duties. More Community policing is increasing. Fire-fighters recruiting started about 2 years from a 9 year absence.

Peter Gentry said that their local Community Policing officer is doing a good job.

Michael Lager and Witham Town Council is a great believer in close community partnership and it works well in Witham.

Witham TC recruit local community police officers to crack down on crime. The local police station is now in the Town hall. ASB is very much down, but drug dealing is still prevalent. CCTV works well in Witham and they have moved away from monitoring by Chelmsford City Council. The extra funding is being used for community street walkers. The Town feels safer in Witham.

Community Safety Partnership is an important department but will impact on operational requirements. Roger encouraged all Councils to get involved with the Community Safety Partnership

Trisha from Toppesfield PC informed the meeting that a new prison is proposed to be built in the area. Has PFCC been consulted on his proposal?

Roger is not a consultee in the planning process but does know about the application.

Martin said that the proposed area is too far from any local transportation (trains / buses etc).

The social impact on the area from this application needs readdressing.

Martin Lee thanked Roger Hirst, Jane Gardner and Liane Edwards for giving up their valuable time this evening. Roger Hirst, Jane Gardner and Liane Edwards then left the meeting
