 - LHP have approved about £270,000 of funding to projects. However, even though an additional £100,000 has been allocated to each LHP there is still not enough money to go around.
 - Many schemes that were on the list up to 2023 have been removed as they do not met the criteria but a further 12 schemes have been added for 2024
 - Only ECC Councillors may vote at the LHP meetings
 - Rumours of town and Parish representation on LHP has been bandied about.
 - Next meeting is on 12th. July 2023 at BDC
 - d) BDC Standards Sub Committee

- e) EALC Executive
- Cllrs M. Lee and P. Lees again raised the issue of EALC funding the insurance required to be taken out by all Local Council Associations. This is still being investigated.
- EALC are undertaking more courses to overcome their financial difficulties due to a year end balance of just £27,000.
- It is understood that their funding arrangements may be ending this year hence more income loss but in-house training is being pushed harder
- It has been suggested that a 4-year financial plan be set up to alleviate any shortfalls in income
- The AGM this held, being held at Colchester United Football Club, is free. The cost is being covered by donations and sponsorships
- Cllr M. Lee is trying to get onto the Finance Committee at EALC
- Worknest HR is a provider to EALC. They are running good courses for Chairs. All courses are being held via Zoom
