County Councillors are invited to LHP meetings but sometimes choose not to attend. Many projects are being delisted through a lack of money available.

Weed killing has been banned due to the chemicals being used.

Commercial recycling - Can this be looked into by BBC?

Only 4 County Councillors are on the LHP but have not met for some considerable time Parish Councils can feed into the LHP for discussion but not guaranteed getting onto the agenda No further dates for LHP meetings. LHP limit budget. It has just £47000. No idea what budget is set for 2024/2025

LHP not being open to other Councillors. Minutes do get published

No communication between EALC, ECC and BBC

Planning

More explanation is needed as to why it is that PC's say one way and BBC says another way Need across the Councils to have more dialogue

CIL workshop to be arranged

Planning officers at BBC do not have local knowledge as it may be outsourced

Planning officers do not take larger applications to committee to make a final decision

There is no consistency in planning decisions

For a simple application it takes 8 weeks from validation to decision report

No supplementary documents are passed to Councils

Can any twinning information be placed in local Council newsletters / magazine? The answer was yes

## 5. Parish Council reports

- Fly-tipping in Navestock still continues: Lawful Development applications are prolific in Navestock Hare coursing is blatant in the area. Neighbourhood watch tried to set up a Speedwatch but was informed that it could not happen due to Navestock having no pavements.
- Parking by parents on the pelican crossing and white lines outside the school in Mountnessing
- Youth offending is still happening in Doddinghurst. Youth workers have organised a Youth committee with other organisations and the Parish Council. Councillors are speaking directly with the youths and it is proving very positive.
- West Horndon PC Dunton Hills Garden Village have not had an application submitted. West Horndon Industrial Estate have new owners and wish it remain an Industrial Estate. On 23<sup>rd</sup>.
  September an anniversary was held in the village for 2 American which crashed during WWII
- Kelvedon Hatch Developments happening for 75 properties in 2 areas. Concern by residents for schools, doctors, road movement and infrastructure. Problem with Essex Highways to get permission to do anything on Highways.
- Ingatestone Further pressure on the infrastructure with all the housing being developed.
- Stondon Massey No fly tipping since last meeting. Speedwatch liaising with Doddinghurst being done twice weekly. 2 speeding signs have been purchased. Village day set for May 2024
- Blackmore and Hook End High value vehicles have been stolen. The doctor's surgery is full to capacity. Memorial service September 2024 for Airman who lost their lives.
