Steve Rhenius welcomed everyone to the meeting and thanked them for attending. Members of the public were invited to table questions.

24/75 Apologies for Absence

Apologies were received from Cllr Peter Schwier (ECC) due to Planning Committee.

24/77 Confirmation of Minutes

Alan Cook proposed, and Anita Chadney seconded with all in favour that the minutes of the meeting held on 10 September 2024 be approved as a correct record and signed.

24/79 Report of District Councillor

Cllr Garrod's report had been circulated prior to the meeting and was taken as read. Cllr Garrod reported. Points noted were:-

- Anglian Water works near Fell Road Members of the public raised concerns regarding mud on the road. Tim Chadney agreed to discuss with the Land Agent. Noted there has been damage to verges on the same road which needs rectification. Action.
- Pharmacies taking Sharps It was noted that some pharmacies were no longer able to take sharps. However, GB Holdings will come and collect sharps boxes from households on behalf of BDC if required.

There were no further questions, Cllr Garrod was thanked for her report and left the meeting.

- b) Parks Anita Chadney reported.
 - Community Orchard grant application, Baythorne End Organisers of the grant had been in touch to ask for a copy of the lease and details of the project. This had now been sent to them and it was confirmed would be discussed at their next meeting.
 - CIF application it was confirmed this had been submitted and the outcome was awaited.
- c) Chair's Report It was agreed that information regarding the collection of sharps boxes would be included in the next parish news. The recent EALC briefing included details of an online safety meeting on 3 December 2024
- d) Highways Alan Cook reported. Alan continued to liaise with local residents and Cllr Garrod regarding the issues around Clare Bridge and the proposals for the A1017 through Baythorne End which were noted as the introduction of a 30mph speed limit, installation of crash barriers at the A1017 junction with Station Road. The issues regarding Clare Bridge continued although it was acknowledged that white lining has improved matters slightly. Mr Cook expressed his exasperation at the lack of engagement or interest from ECC. It was noted that local residents were organising a petition. It was proposed and agreed that another LHP application be submitted.
