23-4/083 WELCOME - The Deputy Chairman welcomed those present.

23-4/084 1 IWMF – The Deputy Chairman welcomed John Tatton – General Manager - Indavar Rivenhall Ltd, who provided an update on the tracking of HGVs through the Village

To prevent vehicles from failing to stop - matrix signs are now operational

Convex mirrors have been installed to aid visibility

A marshall is monitoring all vehicles on Church Road and this will continue until construction is complete

National Highways are now allowing new signage on the A120

There are weekly meetings with contractors and with Blackwater Aggregates

Additional resources will be deployed when new contractors start

2 LINKS SOLAR FARM – In the absence of a representative from Links Solar Farm, the Chairman read a statement provided by Zak Reid, Community Liaison & Stakeholder Manager.

"At the briefing in October, I'll be able to give an update on exact timings, access to the public rights of way, community funds and any other specific questions you may have.

The build timescale is estimated at 18 weeks. We will provide ongoing updates during this time to notify residents of piling works and large deliveries to site.

Our normal working hours are between 08.00 to 18.00 Monday to Friday, and 08.00 to 13.00 on Saturday.

Traffic management

Construction vehicles will enter the site from A120 Galleys Corner and proceed along Long Green, Ashes Road, Lanham Green Road, Boars Tye Road and Links Road and go back along the same route

During the construction period, it is estimated there will be an average of 6-8 HGV trips per day. Whilst this figure is an average, there will often be a higher volume earlier in the construction period and less towards the end.

All staff, suppliers and contractors will be instructed to use the prescribed route through briefing instructions, as per the planning permissions.

Low Carbon will ensure our contractors adhere to the traffic management plan through monitoring and audits. If you see a vehicle you think is related to the project somewhere it should not be, please call us on our community relations helpline. It will be helpful if you can provide part of the registration plate/or time and location to help us identify the vehicle.

If vehicles continue to not adhere to our traffic management plan they will be barred from the project.
