#### 44% of young people completed the Questionnaire

79% of young people visit the Playing Fields at least once a month; of these over 84% play on the swings and the slide; the basketball/netball post is also popular (68%). 73% of the girls walk the dog, but none of the boys do this.

Safety is an issue for over 70% of young people.

We will create a forum to allow young people to influence Parish Council decisions.



### Neighbourhood Plan – The Way Forward

Planning Policy, Road Safety,

A Neighbourhood Plan focuses on Planning Policy for the Parish. Your opinions about housing are clear – no large scale housing development, but for the sustainability of the village some three bedroomed, privately owned, semi-detached houses are required for young couples / families.

You said the parish should be by-passed when the new route for the A120 is determined. Your feedback has been included in the input to the Essex County Council / Highways England Forum which is working on the proposed new route.

In the meantime, you made a number of suggestions for improving the current A120, which have been presented to Highways England for inclusion in the works programme for the next 2 years.

Road safety within the Village was an issue for 70% of young people

We will work with Essex County Highways to improve road safety within the villages of Bradwell and Pattiswick.

Access to doctors' surgeries needs to be improved – your feedback will be presented to the Mid-Essex Clinical Commissioning Group

If we are to encourage young families to the village, improved access to schools and improved transport to schools is required – your feedback will be presented to Essex County Council.

Frustration was expressed by 18% of residents at the Integrated Waste Management Facility for which planning permission was granted five years ago. There are genuine concerns about air pollution, river pollution, increased traffic etc and we will work to ensure these concerns are addressed.
