15/036 Village Hall Lease

Chairman reported that the Charity Commission were not going to grant permission to surrender the Lease. The feeling was unanimous that this was extremely disappointing. We had been working towards this for a year and had regularly chased for progress reports. The Chairman presented a report showing the VHMC had received offers of grant funding in excess of the costs of building work including the essential repairs to make good dilapidations. It was also reported that the VHMC needed to start works by the end of February. The Council was keen for the extension and refurbishment works to get underway and they would like to see the project finished but all Councillors present expressed concern about the risk of potential exposure to the Council in the event any grants were not forthcoming or were reclaimed or there were cost overruns. It was explained that Mr Lockey had said the trustees on the Village Hall Management Committee were willing to grant the Council a letter of indemnity to cover these risks. The Chairman agreed to draft a letter of indemnity and to send this to Mr Lockey. It was confirmed that building works could commence if the Council receives a letter of indemnity signed by each of the trustees, also on the proviso that the works are to stay within the budgeted amounts. Cllr.T.Speakman raised a point regarding the appointment of an independent project manager but was told this would not be cost effective.

Clerk to send letter to the Bank to transfer £9.541.43 from the Reserve fund to the Community Fund. Upon receipt of the signed letter of Indemnity the Clerk also requested

an Itemised Invoice, to be entered onto the next agenda, for consideration of approval, before payment could be made.

Proposed by Cllr.T.Speakman, seconded by Cllr.M. Harden, all in favour, resolution resolved.

15/037 Integrated Waste Management facility (Rivenhall Airfield)

The waste could come from anywhere within the country, and can burn anything and everything. Drop in sessions for public consultation will be arranged but dates are to be confirmed. A condition is in place that the company must set up a trust fund of £42,000.00 to be split between the Parishes affected by the development to provide a source of funds for local projects.
