**CONTROLLED PARKING ZONE:**

It costs £1.85 to park your car via RINGO for up to 4 hours but there is no charge before 8.30am. Or after 6.30pm. It is by no means a perfect solution for everyone but there are still discussions taking place. We will make sure that we are included in the review that will take place at the end of the year.

**VOLUNTARY MANAGEMENT:**

We have not moved forward with this as we had planned. After an in depth discussion with the committee we have reluctantly decided that at the present time, after so many delays and faded enthusiasm, we are not able to continue with our quest.
