The Parish Council would be delighted to hear from any residents interested in serving as a Parish Councillor for Bulmer, as we have one vacancy for a Councillor to be co-opted to serve until normal elections in May 2023.

The Parish Council meets in January, March, May, July, September and November on the 3rd Monday in the month, at 7.15pm in Bulmer Village Hall. Councillors are all volunteers although essential expenses can be claimed. An applicant's name must appear on the current electoral register and/or the applicant should during the whole of the twelve months preceding the relevant date have resided in or within three miles of the parish and/or the applicant's only place of work during the whole of the twelve months preceding the relevant date is in the parish. A co-opted Councillor holds a seat on the Parish Council which is equal to all other Councillors.

The closing date for written submissions of interest is **Monday 9th May 2022**, so that Parish Councillors can consider applications at the Annual Parish Meeting to be held on Monday 16th May 2022 at Bulmer Village Hall, starting at 7.15pm. In addition to the Main Course there will be a selection of homemade desserts and Tea and Coffee.

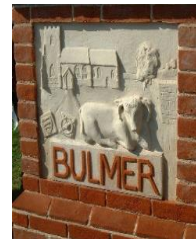

Minutes of a Meeting of Bulmer Parish Council held at 7.15pm on Monday 28th March 2022 at Bulmer Village Hall

1. APOLOGIES FOR ABSENCE

Cllr Nichols apologised for absence.

1.1 Councillor Vacancy: The resignation of Cllr Sarah Kershaw due to other work commitments was noted with regret. Approval to co-opt a new Councillor to fill the vacant seat has been given by Braintree District Council. A notice will be posted on village noticeboards and on the website. Applications received by May 9th 2022 will be considered at the May Parish Council meeting on Monday 16th May

2. MINUTES OF THE PREVIOUS MEETING

The minutes of the meeting of 17th January 2022, amended to record that the absence of BDC and ECC Councillors was due to the clerk's failure to notify them with the agenda, were approved as a correct record and signed by the Chairman

5. PROGRESS CHECK

5.1 Repairs to St Andrews Church tower commence in April. A shed will not be sited on Church Meadow, contractors will cordon off an area as and when required.

6. HIGHWAYS & PUBLIC RIGHTS OF WAY

6.1 Bridleway 27 Bulmer and Restricted Byway 31 Bulmer: Correct signage has been supplied by Public Rights of Way and will be fitted by Cllr Raymond. The new PROW officer for Braintree District, Jason Botelho, has been in contact with Cllr Raymond and the clerk. 6.2 Bulmer Signposts: Requests for Highways to replace broken/missing street direction signs at Upper Houses, Bulmer Street crossroads and Finch Hill have been submitted.

8. REPRESENTATIVES AND WORKING GROUPS REPORTS

8.1 Allotments report: Mr Mike Crome, Allotments Officer, sent a written report. Two tenants from the waiting list have taken vacant plots and there is now no waiting list. Some storm damage is noted.

Action: Allotment inspection together with the Parish Clerk to be arranged for spring.

8.2 Platinum Jubilee: Councillors reported on latest plans from attending meetings with other village groups.

RESOLVED: To grant £130.00 for the cost of hiring musical entertainment for the Village Hall lunch on Sunday 5th June.

10.2 Internal and External Audit: To end of year financial position 2021-22 was noted. Heelis & Lodge Auditors will be used for the internal audit, as for the previous year.

11. UKPN WORKS – Park Lane Allotments

RESOLVED To approve the terms of the revised draft lease, plan and side letter received in March 2022 subject to the following queries:

- To confirm the UKPN hedge maintenance responsibility between points A & B is marked on the plan
- For the rent to be paid annually on 1st January whether “demanded” by the Parish Council or not

12. WAYLEAVE REQUEST – Plough Green

A wayleave request from County Broadband to run fibre along the UKPN power cables at Plough Green, Bulmer Tye CO10 7EE, in order to supply fibre to the property (FTTP) for local residents was agreed in principle at the January meeting. County Broadband is still awaiting permission from UKPN to use their poles.

13. PARISH EMERGENCY PLANNING

13.1 Responses to Braintree District Council's feedback request following Storm Eunice were discussed, see item 13.2.

13.2 To agree updates to Bulmer's Parish Emergency Plan in the event of power cuts and telephone failure

Action: A Zoom meeting will be held to decide on actions to be taken to help in future emergencies, including supporting vulnerable residents. Suggestions for consideration include:

- Linking with Neighbourhood Watch volunteers for local support in power & mobile signal failure
- Leaflet delivery including a list of useful telephone numbers and other contacts
- Plug in BT landline phones (which can be used in the event of power failure)
- Access to generators for emergency use - heating food and water etc

14. BULMER WHATS GOING ON

Options for continuing the Parish Newsletter were considered. Costs of printing have increased and the previous editor has stepped down due to work commitments – the Parish Council wished to record thanks to Paul Banks for his service during his time as editor of the newsletter.

Action: Clerk to produce a special edition of the newsletter, including details of the need for a new What's Going On Editor and the Parish Councillor vacancy as well as the March Parish Council minutes

15. BRAMFORD TO TWINSTEAD TEE

The Parish Council's formal response to the second consultation on the National Grid proposals was approved. The response was in support of running power lines underground, siting the substation at Butlers Wood further back from the road to improve screening and removing redundant pylons.
