# **Bulmer Primary School News**

#### New Play Equipment

At the end of the summer Bulmer St Andrew's Primary School children were excited to see a new outdoor activity climbing frame being erected in the school field. The previous play unit had become dangerous to use and had been cordoned off for nearly a year. Thanks to the PTA for their fund raising, and donations of £8000 the school were able to invest in equipment that will stand the test of time. Three groups of children within the school council, with a representative from each year group, put together a presentation on the play equipment needed, the type of ground cover that would work best and put together proposals for the school to discuss as a whole. They presented their findings to the school and a winner was chosen.



After much negotiation the school team were able to turn the children's dreams into a reality, with the reception children being the first to slide down the climbing frame on its unveiling day.

#### Local School Join in with the BIGGEST Coffee Morning / Afternoon of the Year.

Bulmer St Andrew's Primary School joined in with the nation and held a Macmillan coffee afternoon in the school hall on Friday 7<sup>th</sup> October. All the children joined in with raising money for this worthwhile cause, by buying cakes and drinks, inviting their friends and families to attend and taking part in the prize draw. In total the school raised £240.

#### NATURE DIARY

We seem to live in a world of clever acronyms, buzz words and catch phrases and have come to accept them as the "norm"

I was though, a little taken aback when my old friend Robin Ford introduced "Shifting Baseline Syndrome" into a talk he gave to the Lavenham Naturalists group !

A somewhat curious phrase -- but one which explains how our idea of what is the "norm" in all manner of things, will alter over the years. For example, before Dutch elm disease ravaged our countryside and robbed our landscape of some truly magnificent trees, a mention of elms would have conjured up a picture in our mind's eye of a row of these mighty giants standing sentinel along our hedgerows. Thirty odd years on, and what do we visualise now ?.... an often scruffy hedge (but still an important Natural habitat), invariably including some branches dying off, as they become



mature enough for the bark to crack and let in the beetle, which carries the deadly fungal spores. So our perception of "elm" may have moved from stately tree to scruffy hedge.

This is particularly relevant to me because, as a child, one of the defining features of our home at Upper Houses was a group of towering elms just across the field in front of us, one I would think approaching 90 feet tall. I could look across to these every morning without even venturing out of bed. One of my ambitions was to climb this giant, but having no side branches for the first 15ft or so, it always defeated me. But another elm closer to home, a mere sixty footer, was easy game. In 1953 (Coronation Year) I climbed up and fixed a Union Jack to the very topmost branch, swaying about alarmingly in those precariously thin branches.

To return to shifting baselines, some of my own personal lifetime ones are :- *from* much smaller fields with the occasional pasture with bullocks or sheep grazing... to the huge purely arable fields of today ...... *from* harvest fields being cut by the binder, and of shocks (or stooks) where the sheaves were stood up to finish ripening, often, in those days before herbicides, with thistle down blowing from their tops......to fields with not a weed in sight ( black grass excepted !) and being harvested in a matter of hours by our modern day monsters.... *from* turtle doves and cuckoos calling almost continuously from the hedgerows and huge mixed flocks of house sparrows, chaffinches, greenfinches, linnets etc. Often 400 birds or more feeding on the winter stubbles..... to the turtle dove and cuckoo becoming rarities and any flock of sparrows and finches numbering over 50 or 60, being quite notable. I could go on.

We had a real surprise visit by a couple of snipe in October. Wendy noticed them first, a little way down the lawn. They often their long beaks into the turf, no doubt seeking worms. They ambled their way down to the field gate where they seemed quite happy. A dog suddenly trotted along the footpath, within a few feet of them, the birds must have seen it but remained quite unperturbed. However it was a different tale when the dog's owner appeared, the snipe rocketed upwards and sped away. these birds coincided with the reported influx of snipe migrating in from northern Europe, helped by some strong easterlies. Several different species were coming over at the same time



different species were coming over at the same time, especially redwings, the next day a couple of small flocks of them winged their way past. Just a week later we saw our first fieldfares, with about 60 of them feeding out on the field. We had an amazing 20 minutes of bird watching in the garden on Nov 14th, in that time counting 18 different species. Most of course were garden regulars, various tits a robin, goldfinches, Blackbird etc, three were occasionals, long tailed tits, song thrush & green woodpecker, but two are what I would regard as garden rarities, goldcrest and meadow pipit. However a day later there were getting on for 100 pippitss feeding on the field just behind us.



Last edition I showed a picture of "chicken of the woods" a large edible fungus growing on an oak tree. Recently We discovered another monster fungi, growing in a cricket bat willow plantation beside the Belchamp Brook. I spotted it from some distance, not believing at first what it was, because of it's size. Growing from the ground, close to a large heap of wood ash, it was about 2 feet in diameter and dome shaped, with masses of contorted gelatinous "petals" for want of a better word. Looking it up at home I discovered that it was the cauliflower fungus, also known as the brain fungus. It seems to be regarded as something of a delicacy, but this one was way past it's sell by date, so there were no culinary adventures.

The autumn colours this year have been truly stunning. The deep bronzes of the oaks and the bright yellows of maples, making a rich tapestry spread across the valley behind us in Bulmer Street. Particularly so one evening when the colours were intensified by low sunlight flooding across the fields. #### 16/161 Welcome and Apologies of Absence.

Chairman welcomed everyone, apologies for absence received and accepted from District Councillor Wendy Scattergood. The Chairman presented the Freedom of the Village to Mr M.Crome, and Mr Crome expressed his thanks.

#### 16/162 Declaration of Interests.

Received from Cllr.C.Leigh regarding item 16/173 Ref: S16/00321/TPOCON.

16/163 Public Participation Session with respect to items on the agenda and other matters that are of mutual interest.

A member of the public raised concerns regarding vehicle access issues and dropped kerbs at Bulmer Rise. It was asked if the Clerk could write a letter to the developer to ask if the area could be kept tidy. Footpath opposite the Fox, hedge over hanging footpath. Path way from the Fox to Sudbury has been reported that it needs clearing.

**16/164** County Councillor David Finch & District Councillor Wendy Scattergood to address the members if present. Cllr.David Finch reported the budget for next year and that they will need to find savings. Social care concerns regarding the growth in the community, older population in Essex above average and funding it is limited. A drain causes flooding on the A131 near its junction with Hedingham, Cllr.D.Finch to arrange a site meeting with Cllr.R.Raymond.

#### 16/165 To confirm the Minutes of the Parish Council Meeting held on 19<sup>th</sup> September 2016.

Approved as a true and accurate record were signed by the Chairman.

Proposed by Cllr.C.Leigh, seconded by Cllr.R.Raymond, all in favour, resolution passed.

#### 16/166 Allotment Issues – Footpath.

To discuss and consider the following options.

**1.** Claim: For this to be successful it would have to be proved that the footpath had been walked regularly for the last 20 years. The claim would not be dealt with by him but someone from ECC legal department.

They would complete the relevant forms and check the proof of the 20-year walking. There would be no cost to the Parish Council and ECC would be responsible for maintaining the path and the footpath would be added to the definitive map. The process could take some time.

Proposed by Cllr.R.Raymond, seconded by Cllr.P.Benns, 5 against

**2.** Agreement: Public Rights of Way Officer would deal with this and he would arrange for the paper work to be completed and there is no cost to the Parish. The one problem with this is he would have to get ECC to agree to this because of the cost of maintenance and mentioned the difficulty in gaining funding at the moment. He said it might help if the Parish Council would agree to maintain the footpath and this would have to be written into the agreement.

A responsible person(s) would be required to sign the agreement on behalf of the Parish Council. There would need to be fingerposts marking the footpath at both ends for both options.

No proposer. No Vote.

The Parish Council were unable to make a decision regarding the above item.

The Parish Council confirmed that the footpath is to remain open to the public and for it to remain as it is.

#### 16/167 Precept/Budget for 2017/2018.

As required by section 33 of the Localism Act 2011, Parish Councillors are obliged to leave discussions where they have a disclosable pecuniary Interest. To participate in the setting of a precept for the Council. The councillors will require a dispensation, and for this purpose, Bulmer Parish Council resolves to delegate to the Clerk the power to grant a dispensation from exclusion to all Councillors for the purpose of considering and setting the precept.

Proposed by Cllr.C. Bennett, seconded by Cllr.S. Buchanan, all in favour, resolution passed.

#### 16/168 Precept 2017-2018.

To consider various options. Further information and headings to be provided by Cllr.P. Benns. This item deferred until next meeting.

#### 16/169 Affordable Housing.

Survey now received. 290 forms sent out to residents for completion, 96 have been returned. Majority of which were from 56 year and over. Residents are looking to downsize. No young families looking for affordable housing. The Parish Council to raise this issue again with residents at the next Annual Parish Assembly.

### For Information - What is the fundamental of Essex DaRT?

DaRT means demand responsive or Dial and Ride Transport. It is formed of a number of minibus vehicles, typically accommodating between 8 and 16 passengers. These minibuses operate a range of bus services serving rural communities where conventional buses are not viable operations. They differ from normal bus services, in that they are totally flexible and can divert on and off route to collect and drop off passengers within their operating area. DaRT works by grouping bookings together to make it viable. It is not a taxi service, as there must be sufficient volume of passengers with similar itineraries. Most DaRT work, is former bus routes, and group bookings. But unlike a large bus, DaRT only needs three or four passengers to make a group booking. And, when not operating a timetabled bus route or group booking, vehicles may be available for individual runs where no alternative transport is available. DaRT operates between 0600 and 2000 Mondays to Saturdays inclusive.

Also, unlike a conventional bus, you need to book your seat, and register as a customer, at least two hours in advance of travel, and can book up to three months in advance of travel. But, if you travel regularly, you do not need to book every single time you travel, as you can make a regular booking which lasts for three months.

North Essex DaRT has carried more passengers every month since it first commenced.
