NATURE DIARY



PAINTED LADY

I enthused in the last "What's On" about how good the spring had been for butterflies, like the brimstone, orange tip and holly blue. The summer has been similarly kind towards these delightful winged gems. The most noticeable have probably been the painted ladies. These are migratory and have good and bad years as far as reaching us goes. They travel amazing distances. The first brood hatch early in the year in North Africa, many of these will migrate north, to have another brood in Spain or southern France. Some of these will continue north, to finish up in our gardens and in particular on the buddleias. Here they will be competing with the "locals", peacocks, red admirals and small tortoiseshells for the nectar. It is believed that some painted ladies make the trip from Africa in one hop, being carried here on strong upper atmosphere airstreams, and also that they may even make a return migration south at the end of the summer.

I am always amazed at some of the unusual places that plants will sometimes take root and grow, or indeed just come up. On the demolition site where the new Gainsborough House Gallery is to be built, a very unusual

plant has sprung up, an apple of Peru, one of the Nightshade family. It is possible that the seed has lain dormant under the old Labour exchange, which would have been built just before the last war. The plant was first introduced into Britain in the 17th century. The flower is pale blue and bears very distinctive seed pods. It tends to pop up on bare ground and waste places and is closely related to deadly nightshade and thorn apple and like them is extremely poisonous.



Looking down right in the middle of Roy's car park, some

greenery was just poking out from one of the rainwater gulleys. It was a healthy example of a harts tongue fern, really flourishing in the permanently damp and partially shaded position. Looking up in North Street Parade there was a rape plant bearing a good crop of seed, eking out an existence in the rainwater gutter above on of the shops.

An interesting and somewhat puzzling little episode was passed on to me by Margaret Mills. She saw what appeared to be a young woodpigeon, dead on her lawn. An adult was standing there seemingly watching it. Then extraordinarily it went and stood on top of the dead bird. Meaning to clear away the dead bird, but forgetting, the next morning she saw the adult again sitting on the dead bird. A couple of other reports demonstrate what we have gained in the way of wildlife over the last 10-15 years or so. Dean and Sarah saw a pair of red kites in the Belchamp Valley, which probably indicates breeding locally. Steve Morgan told me of spotting an otter with two cubs in the Stour from Ballingdon Bridge. Both of these sightings are signs of the recolonisation of the kite and otter over the last few years, following on from the spread of the buzzard to East Anglia.

On the 17th June the number of birds in our garden was given an unexpected boost. Looking out onto our patio, I was suddenly aware of about 10 little balls of fluff running around --- recently hatched red legged partridge chicks. Their mother was gently calling them trying to lead them into cover. A very attentive mother, she had obviously hatched her brood in a nest hidden somewhere in the wild section of our garden (which is most of it!) A couple of days later, she stood her ground in a great show of bravado, as I had to free one of the chicks that had become entangled in the netting of the vegetable cage. Coming close she scolded me for interfering with one of her offspring, and showed little fear of me as I gently released the wayward chick. The last I saw of them was a couple of days later, when I was pleased to see that she still had 9 chicks with her.

In May and June we often saw brightly coloured red and blue black cinnabar moths in the garden. These moths more normally lay their eggs on ragwort, but as we have none in the garden, they were laying their eggs on groundsel, a well-known garden weed which is a much, much smaller plant, only reaching about 8 or 9 inches high. When the caterpillars hatched,

more than skeletons. We often found the striking black and yellow striped caterpillars marching along in quest of another groundsel to munch on! Like

ragwort groundsel contains a harmful toxin, The caterpillars, obviously immune to this, ingest the poison and become toxic to any other creature that misguidedly eats them. The black and yellow stripes are a warning to any other creatures, eat me at your peril! A good example of protective colouration



Every year when the corn on the field behind us is ripe, we get invaded by a host of house sparrows. These use our hedge and trees to shelter in, between carrying out mass raids on the standing crop. At one time this year I counted well over 50 birds in the flock. Did anyone look for the pyramidal orchids flowering beside Church Road that I mentioned in the June Nature Diary. They flowered outstandingly this year, from less than 40 blooms last year they jumped up to almost 80 this.

063/2019 Essex County Councillors report – Cllr D. Finch

Key Messages: 2019/20 - Summer Edition

Balanced Budget for 2018/19

As you know, delivering a balanced budget has always been the number one priority for Essex County Council under my Leadership. I'm pleased to be able to say that last year's budget was indeed balanced, thanks to the excellent work of the Cabinet Members and Council staff.

• Savings in the budget for 19/20

Looking ahead to next year, we are on track to make the £72m of savings required to deliver another balanced budget. The declining financial support from central government means this budgetary pressure has increased year-on-year. We are strongly lobbying Essex MPs and Government Ministers to make sure the next Government Spending Review has a long term, fully funded settlement for Local Government so we can deliver the public services our residents need.

• New Cabinet Member for Economic Growth

We made a few changes to our Cabinet in May of this year, and in particular I'd like to highlight the appointment of Tony Ball as the Cabinet Member for Economic Development. Tony brings a wealth of experience to the role and has a vision to transform the economic potential of the county – attracting inward investment and great jobs for our citizens.

Reports of potholes decreased by 45% in Essex between 2015-2017

National figures released by the RAC in December 2018 showed Essex bucking national trends, where reports have been increasing. The figure reflects our hard work in tackling potholes, with extra funding/resources deployed to clear the backlog particularly following the "Beast from the East" cold snap at the beginning of 2018.

Reducing Air Pollution

We're working had to improve air quality in the county – we have set up a working group led by Cllr Simon Walsh, Cabinet Member for Environment and Waste

• Reducing Plastic Use

In December last year the government launched its new resources and waste strategy which aims to eliminate avoidable waste of all kinds (including plastic waste) by 2050.

ECC is doing its own part – we have established a specialist team in the county for just this issue, who have started by removing as much single-use plastic from County Hall and replacing them with more environmentally friendly alternatives. This work should be completed by September of this year.

We are also working closes with the city of Chelmsford, to do the same in the Business Improvement District (covering the city centre) which is home to more than 400 local and national businesses. We hope to roll out the programme across the county once we have successfully set up in the area.

Healthy Living

ECC is exploring ways it can help people make healthier choices around the food they eat, exercise they do, and other things that contribute to better health.

Footways

Administration is investing additional money in footway repair, recognising the concerns of residents in this area. £700k of additional funding and using £1m from the DfT grant we received in November.

Essex 2020

Next year the Council will be launching a programme of events to celebrate Essex's history as a home to arts and sciences of all kinds – there will be things for all the family up and down the county, throughout the year, and I look forward to be able to provide more information as we get closer to 2020 itself.

• Housing Infrastructure Bids

We have submitted more than £500m of infrastructure funding bids to support infrastructure improvements in Essex linked to our growth aspirations. We strive through this process to win funding for key infrastructure upgrades ahead of new housing developments being built across the county.

Essex County Council is the most efficient/effective Council of its size in the country and ranks seventh overall Consultancy iMPOWER surveyed 150 upper-tier councils, with ECC 7th for spending money effectively and getting the best results for residents.

The results are drawn from an analysis of performance in six key areas: children's social care, older people, disability, health and social care, housing and homelessness, waste and recycling

The council is passionate about delivering value for money and its performance has been nationally recognised through the IMPOWER report. But the council doesn't sit back on its laurels, and is doing further work to develop ways of monitoring its productivity levels across all services to ensure it remains one of the best authorities in the country

ECC have only increased Council tax in 4 out of the last 9 years (including 2019/20)

Devolved funding to Parish Councils

Parishes have been invited to take part in a pilot where they would undertake devolved highways functions, including grass cutting and special verge maintenance, weed control, tree and hedge cutting, minor footway repairs, installing/maintaining signs, winter salt bags, maintaining bus stops/shelters and maintaining Public Rights of Way

15 Parish Councils have expressed an interest in taking part in the pilot

• Reducing unauthorised Gypsy and Traveller encampments

Working with the Police and Crime Commissioner, we have seen a 40% reduction in unauthorised Gypsy and traveller encampments

Essex Local Delivery Pilot funding

ECC being awarded over £10m by Sport England (with Tendring, Colchester and Basildon) for piloting ideas to increase sport and physical activity

The Essex Local Delivery Pilot (LDP) which is tackling population levels of physical inactivity across the county secured the maximum grant of £10.68m from the funder Sport England.

The LDP is governed by the Health and Wellbeing Board, and one of the seven priority projects for the Essex Partners and Essex Assembly.

The LDP is using whole system change to hardwire the value of physical activity into key agendas including health, planning, transport, social care, and the built environment.

Initial testing will mainly take place in Basildon, Colchester and Tendring, and the learning from the pilot will be shared across Essex through replication and scaling.

The LDP lifespan is currently until 2025.

• Gang related crime prevention

An additional £500k has been allocated to the Police and Crime Commissioner to support multi-agency work on gang related crime prevention in this year's budget. Discussions are ongoing between ECC and the Police as to how this fund is to be used.

Mental Health

An additional £1m has been allocated to mental health in this year's budget. Cabinet Members are currently in conversation on how best to use this additional funding

• Digital Community Engagement

ECC is working with community leaders in social media to bring together Facebook Administrators of Community Pages from across Essex. We are supporting locally devised and delivered projects led by local community-based Facebook groups with small grants of a few hundred pounds that can be very quickly accessed. We are working with the Essex Association of Local Councils to help them to also work in this way.

While we are keen to help to address issues locally identified by Facebook groups, we have been delighted that most of the projects align well with our own priorities including around mental health, loneliness, physical activity and domestic violence. A lot of work has been done but we see this as the start of a journey and want to expand this approach across the whole of the county. We are very keen to work with all local communities in this way and would be keen to see groups led by Facebook administrators or similar social media leads covering all of Essex.

• Essex Housing update

Essex Housing has undertaken an ambitious programme to build affordable housing that supports the provision of specialist accommodation for people with learning difficulties across the county. The team also works on projects to construct public buildings such as schools and have achieved recognition from industry experts; wining the 'Community Benefit' award for the eastern region from the Royal Institution of Chartered Surveyors.

Homelessness

As a sign of ECC's commitment to tackling homelessness and it's causes across the county, an additional £250,000 has been allocated to pay for mentors to help support up to 50 people at risk of rough sleeping and 150 people at risk of losing their homes. This will allow us to build additional capacity into the existing programmes working with targeted groups in clearly identified areas of need, with the flexibility built in to respond dynamically to changes in demand. The programmes are:

Horizon who work with some of the county's most chaotic individuals providing a highly intensive and focused intervention services. It works with the customer to support them in making the life changes needed to break negative cycles of: rough sleeping, poor mental wellness, substance use dependency, offending behaviour and unemployment. This has been shown to be extremely successful in turning around the lives of the most entrenched individuals.

Essex Floating Support which is a county wide homeless prevention service working with families and individuals assisting them to live independently and to prevent episodes of homelessness.

1) Update on - UK Power Networks Electricity Diversion Works - The work involves removing several spans of overhead electricity network and replacing it with underground cable, as well as a ground mounted substation which will replace the pole transformers. UKPN have identified a possible location for the substation on the land which would also include the removal of some low voltage overhead network.

Cllr M. Crome outlined the proposal of UK Power for the in substation.

An alternative site is being looked at but their first choice is on the junction of Church Road and Park Lane.

It must be removed from where it is now as the landowner has to give permission to access the substation.

Cllr R. Raymond stated that this substation would not be sited well in the allotment area.

Cllr M. Crome proposed that UK power comes back with an alternative site?

2) Update on vacant Allotment plots

Troublesome Plot – Cllr M. Crome has met with the tenants and they removed items from the ditch and I am advised they have found a gate key, so will no longer be climbing the gate.

Un-Cultivated Plots

The plot holders have received a letter reminding them to cultivate their plot or terminate tenancy, 2 have now started to cultivate/prepare their plots. The other 2 have decided to terminate. I will continue to monitor. One plot has some tools in an old shed, they do not want them and I propose to offer them to volunteers who will be clearing this plot. And no-one wants them I will donate to a charity, unless Cllrs have alternative suggestions.

I am pleased to say that these 2 plots and all other plots have now been taken except for 1A, which is being considered by a current tenant.

Gate Post

The gate post that had become loose due to the gate being climbed has been made secure with thanks to Peter Fulcher, and we await wet weather to see if it remains secure. If not, a right-angle brace will have to be installed at a small cost.

Skip Request

A request for a skip was made by the tenant who has the plot next to the hedge of no. 1 Park Lane to clear the spoil removed after he cuts the hedge and trees under their agreement. BDC did offer to remove it at a cost, but the tenant has now disposed of the spoil themselves.

3) Update on Water pipe extension

New Water Pipe. The additional water stand-pipe cover has been ordered and the contractor hopes to have commenced installing the pipe within the few weeks.

The tenant of plot 2 has now had the tenancy for over a year and still has no part of it under cultivation despite being written too reminding him of his commitment. He is now is moving house this month and I have asked him if he is to terminate his tenancy. He wishes to continue and says he anticipates being on top of it by Christmas, is this acceptable? The rents are due to be invoiced this month, should we remind him again?

I do have a potential new tenant on the waiting list.

The water extension standpipe has now been installed and is working well. Both standpipes are now without locks due to the malfunctioning lock reported earlier.

The lock was originally necessary when there was not a fence and locked gates.

Do we now:

- purchase two new locks and replace all tenants' keys, all tenants have water keys
- purchase two-barrel locks and refund water deposits when issuing this year's rent invoices
- leave them unlocked and refund deposits and all tenants charged a proportion of the water useage.

With regards to the issue of the hedge between plots 1 and 1a and 1 Park Lane, are we able to establish ownership of the hedge, and do we wish to talk to the owner of 1 Park lane before asking a contractor to cut the hedge.

Annual rents are due to be issued at the end of September, to those tenants who now have had the plot for more than a year together with a discount of £10 refund proportion of the water usage. The latest list of tenants is included with this report. Garden a grazing rent are also due.

19/01516/FUL - Land South Of Hedingham Road Bulmer Essex

Proposed agricultural building

BPC Decision: **REFUSE** this application

The proposed building is not necessary to support agriculture nor an existing commercial operation which requires a countryside location and which contributes to the rural economy and thus represents an inappropriate form of development in this location and an unjustified intrusion in to the countryside of harm to the amenity afforded to the countryside location.

The proposal is therefore contrary to the NPPF, Policy RLP2 of the Braintree District Local Plan Review 2005 and Policy CS5 of the Braintree District Core Strategy

The previous rejection of "18/00210/FUL" was appealed by the proposer and the appeal was rejected against 12 separate reasons, too many to list here so the Parish Council would like to propose that they paraphrase all the reasons presented in document "appeal Decisions" - see link https://publicaccess.braintree.gov.uk/online-applications/files/E823AEF4AB10848430DDF379858AB79B/pdf/18 00210 FUL--1550068.pdf

The Parish Council would like to draw specific attention to the clause 7 in the appeal rejection letter linked above which reads The proposed building and access route would result in a substantial built form within the countryside. Regardless of the materials proposed, the introduction of the building and access providing a use which would not to be appropriate to the countryside would introduce a more developed nature to this currently open site. This would be harmful to the open countryside character of the site, failing to protect and enhance the area's landscape character."

The previous and replacement planning statements describe the building as either, "steel framed and to be clad in timber on the walls with a fibre cement roof" or "steel framed and to be clad in profiled tin on both the roof and walls" – Neither of these statements go any way to alleviating the original planning concerns, and seem totally out of style with the rest of the area.

The access to the site is already dangerous and on a tight bend which is considered an accident blackspot, the slow turning of farm machinery and other large vehicles into this space coupled with the necessary modifications to the access to accommodate such vehicles all present serious safety concerns to other road users. These issues were also raised in the original rejection of the previous application for this development and the Parish Council see no provision for improvement between then and now.

The Parish Council also supports the objection letter from Peter and Elizabeth Fulcher.
