Re-Ordering of St. Andrew's Church Bulmer

Permission has been granted by the Diocese of Chelmsford to remove the pews in the Nave and North Aisle and replace them with chairs. Chandelier heaters will also be fitted to replace the heaters that are in the pews currently. These will also provide additional lighting. The pews currently in the Chancel will stay and suitable redundant heaters will be fitted in those pews where there are no heaters fitted currently. The purpose of this re-ordering is to make the church a more welcoming and flexible space for worship. The work is due to commence in middle of March 2024 with completion by beginning of May 2024.

Do you use kerosene oil for heating?

Would you like to pay a lower price for your heating oil, why not join the Bulmer & District Oil Syndicate (https://e-voice.org.uk/bulmeroilgrp/). This is a non-profit making group, and is run by Mike Crome in Bulmer. I have now been running this syndicate for over 5 years with around 150 members. With the current high prices it is even more important to join the group and pay lower prices than you would get on a single order. Can you afford not to be a member of the group, especially remembering that it costs nothing to join and there are no running costs. How the group works:

The preferred method to place an order. You will receive a reminder of when orders have to be placed. If you wish to place an order, complete the order form with the quantity you require (min 500 litres, this is a statutory minimum requirement). You do not need to order each month, only when you need it! Your order will be acknowledged by the system, and generates a report for me when placing the eventual order. When the cut-off date has passed, I will contact various suppliers and place our order with the cheapest one. When placed I will email all members (whether you have ordered or not so you can see the way prices are going) with the name of the supplier, the agreed price and approximate delivery date. The supplier will contact you regarding payment and delivery. You pay them directly. Most will accept debit/credit cards or by BACS, except if the order is with Active Fuels who do not accept Credit Cards.

Bulmer History website update

Griggs Farmhouse

With the recent sale of Grade 2 listed Griggs Farmhouse which is to be sympathetically renovated. The new owners are looking for any old photos of the inside or outside and details of its construction. If you have any information, please email the history site at info@bulmerhistory.co.uk. The website currently has some of its history along with other properties in Bulmer.

Approaching Bulmer Street from the Gestingthorpe end, one of the first buildings you see on your left is the 17th Century Griggs Farmhouse, the lands were then farmed as part of Auberies estate. By the latter half of the 18th Century two farms, one north, the other south of The Street, were combined as Griggs and Swains owned by William Jennens of Suffolk. When he died in 1798, aged 98, he was reputed to have been the richest commoner in the country. His holdings close to two million pounds in value, were also Butlers, Black House, Jenkins, Kitchens and Tye Corner farms. Dickens' novel "Bleak House" was said to have been based on the Jennens Case.

In the 19th Century William Bird farmed Griggs, then Charles Bird who farmed 280 acres with 12 men and 3 boys in 1871 and finally John Burlingham, a great supporter of the chapel.

At the turn of century came W. S. Courtnell who farmed it together with Kitchens. Tom Rowe recalls that in 1910, before tractors were generally in use, the chassis of an old motor vehicle was adapted for pulling a self-binder. The barn (now Suffolk Hall), dating from the same period as the house, has been converted into a dwelling.

Opposite Griggs are five houses erected on what was once a meadow known as Stackyard pasture, part of Swains Farm. Swains Cottage, built about 1902, replaced three earlier cottages on the site.

From 1937-51 the Walkers lived there, a show-business family; Mr. Walker was a musician and acrobat and Mrs. Walker a singer. The two daughters were acrobats and performed with a third person as "The Three Garcias". They appeared at the Palladium and other leading theatres. At various times they appeared with many well-known acts and personalities such as The Crazy Gang and Gracie Fields. In 1947 they appeared in a Royal Command Performance.

The house (Fylok) and a bungalow in the Roman style (Oatlands) have been built in the grounds of Swains Cottage, also St Andrew's Rise and the Swains Cottage bungalows on allotments.

2. MINUTES OF THE PREVIOUS MEETING

The minutes of the extra ordinary meeting of 3rd October 2023 were approved as a correct record and signed by the Chairman,

4. PUBLIC FORUM

5. PROGRESS CHECK

5.1 Defibrillators: The 4 Bulmer defibrillators are now installed at 1. Kitchen Hill, 2. By Bulmer Street noticeboard, 3. The Fox at Bulmer Tye and 4. Church Road by post box. These will shortly be registered with the Community Heartbeat Webnos system which shows the ambulance service the nearest defibrillators which are "rescue ready" so residents can be directed to use them during a 999 call. The code to access each defibrillator will be displayed on the outside of the cabinet,

this is recommended as a measure to ensure no lives are lost due to lack of access. Incidents of theft or vandalism of defibrillators are a very low risk but the defibrillators will be checked and monitored at least monthly and the policy reviewed if problems occur.

6. HIGHWAYS & PUBLIC RIGHTS OF WAY

6.1 Local Highways Panel (LHP): A LHP application for improvement of pedestrian & playground signage at Coes Meadow entrance in Bulmer Street has been submitted.

6.2 A131 Footpath Bulmer Tye: Cllr Schwier, ECC and Cllr Holland BDC had supported the Parish Council in raising this issue with Cllr Tom Cunningham, BDC Cabinet member for Highways. Although the verge has been cut, the side growth of invasive weeds in the footpath is still making it dangerous and inaccessible for pedestrians. This was raised again with Cllr Schwier when he reported after item 12. Points to note are:

- Lack of a spring verge cut causes invasive weeds/grasses to spread horizontally and selfseeding in footpath cracks. The autumn verge cut is done with a tractor mounted side flail which does not tackle this low growth.
- Essex Highway Rangers used to deal with the lower growth on footpaths (this is called siding) by selective spraying or clearing. Highway Rangers were disbanded in April 2023 so this is a service which since this year is no longer provided. Use of weedkillers has been reduced generally by BDC and ECC
- Parish Council responses will be sought for the planned BDC review of the autumn only verge cutting trial during the second half of 2024/25.

Reporting problems: All residents are encouraged to use the https://what3words.com/ in photo mode allows a photo to be uploaded with the exact location, which enables Highways inspectors to identify the site and the problem more accurately. This saves time and avoids errors which delay remedial action being taken.

Action: Photos and other evidence to be sent to Cllr Schwier to enable him to raise this again with Highways

7. REPORTS

7.1 Police/PCSO/Neighbourhood Watch - Changes to Neighbourhood Watch activity in the village were noted. Action: Clerk to add Braintree District weekly Neighbourhood Watch newsletters to the Bulmer website.

7.2 Essex CC report – Cllr Schwier arrived and reported between items 12 & 13. He then left the meeting.

ECC updates: These are emailed regularly to the clerk. Those relevant to Bulmer residents are now shared on the new Latest Posts section on the Parish Council website https://e-voice.org.uk/bulmerpc/. Bulmer residents are encouraged to request membership of the website and opt in for weekly email updates on new content that has been added.

Essex Primary School applications: these are now open until 15th January, details available at https://www.essex.gov.uk/schools-and-learning/schools/admissions/primary-school-places

Highways: Drain jetting crews have been working ad hoc to clear drains following heavy rain **Sandbags**: These are not supplied by ECC, householders needing a supply should contact the Environment Agency. ECC provides funding help for residents with flooding concerns, call Essex County Council general enquiries on 0345 743 0430 Monday to Friday, 8:30am to 5:00pm or use the general enquiries online form at https://www.essex.gov.uk/general-enquiries

Winter operations: pothole repair work is not effective when carried out in freezing conditions. Crews are redeployed on winter gritting and there are now 50 gritters, with 2 smaller electric ones for accessing narrower rural roads. 40% of highways are covered each night, spreading around 21,000 tonnes of grit. Last year the gritters were deployed on 70 nights.

ECC Consultations: Draft Waste Partnership consultation ended on 22nd November, and the Vehicle Booking for recycling centres consultation ended on 19th November

7.3 Braintree DC report – Cllr Holland apologised for absence due to a conflicting meeting and sent a written update:

Budget: BDC is currently amid the budget setting process and a key stage is reached this week when the Budget is the main subject of the Corporate Scrutiny Committee on which I sit. So, if there is a matter relating to this that you want to raise, one option is to drop me a line so that I can feed it into the process.

Verge cutting: I continue to make the case for verge cutting appropriate to ensuring the safety of our community members.

Planning: The Kitchen Hill planning application comes before the Planning Committee on Tuesday 28th November. If there are matters that you feel you have yet to raise with respect to this application, you can of course still feed them into the decision-making process by registering to speak and attending the meeting

Planning Policy: new policy documents that have the potential to impact our lovely rural area are being developed or adopted. Biodiversity net gain is a recent one with energy and infrastructure. Supplementary Planning Documents yet to come. We should also be aware that special area status with respect to improving the natural environment is being worked up. I feel that we must understand this because it could be highly beneficial to us. This matter is being driven by the County Council with the support of BDC.

Meetings: My intention is to attend the entirety of Parish Council meetings such that I am aware of all of the issues that concern you. I very much hope to be able to attend your next meeting. In the meanwhile, if there is anything you feel I can help with in my role as your District Cllr, please let me know

8.1 Allotments report: Mr Mike Crome, Allotments Officer apologised for absence and sent a written report. Water extension stand pipe not yet installed. No further work carried by UKPN on installing base for transformer. **Action**: Clerk to contact both contractors for an update. At least 4 plots almost or fully overgrown, although rent is being paid, except for one who as in previous years is late in paying. They have been reminded their rent is overdue and will be chased up again.
