### **BULMER DISTRICT HISTORY**

### GROUP UPDATE

Have you seen this bugle in our Village Hall and wondered about it's origin and who were the last owners?



This Bugle was discovered in the village in 2011. It belonged to the 1st Bulmer Troop of Boy Scouts, which existed from 1921 to 1927. The Troop was part of the Sudbury Boy Scouts District, so they wore the Suffolk county badge as part of their uniform. Inscriptions on the instrument reveal that it was made, or sold by Metzier of London and had originally been presented to F Brown, Bandmaster of the Church Lads Brigrade in 1903. In 1925 he presented it to the Bulmer

Troop of Boy Scouts. We can find no record of F. Brown, or the C.L.B. group that he belonged to.

The Troop was was founded by Col. Redmund St. George Burke of the Auberies. Included in the many proficiency badges that they could earn were, Buglar, Cyclist, Swimmer, Marksman, Poultry Farmer and Entertainer.Many "old Bulmer" names can be seen in the register, Blye, Felton, Messant Radley, Rash, Rowe, and no fewer than six Raymonds. Three boys became "**King**" Scouts and some were expelled. You can read about all the members, their badges, who was expelled and those who became king scouts here at www.bulmerhistory.co.uk

### OROTHY CORNELL 1925-2024

One of Bulmer's most beloved residents died in late November, six months before her 100th birthday

Dorothy Cornell spent her childhood in Gestingthorpe, where she attended the village school. She then worked on local farms, milking cows and delivering the milk in a pony-cart around local villages—a role she continued in World War II, as part of the Land Army.

In 1946 she married Jack Cornell whose parents had kept the Bulmer 'Cock and Blackbirds' and whose father had also operated a traction engine and threshing machine.

Initially living in Belchamp Otten, the couple soon moved to Bulmer, before taking on the tenancy of a small farm in little Maplestead, which they were later to buy.

Following Jack's death in 1988, Dorothy eventually moved back to Bulmer, living in Park Lane, not far from where she had lived 60 years before! For over four decades she was a most devoted member of Bulmer History Group, attending almost every single meeting, whilst similarly enjoying afternoons with the Skylarks. She will be forever remembered for her happy disposition, friendly chuckle and gift of finding

laughter in almost any situation. No one ever met Dorothy without feeling 'lifted' and coming away a happier person.

Her funeral will be held in Saint Andrews Church, on December 18<sup>th</sup> at 1.30p.m. **Ashley Cooper**

# FLY TIPPING IS THE ILLEGAL DUMPING OF ANY ITEMS

It could be something as small as a dog poo bag or hedge/garden cuttings, but **YOU** could face prosecution and an **unlimited fine** or even **up to 6 months in jail** if your waste is fly tipped. Avoid a fine. Put items in a bin.

Although it may seem harmless to deposit your garden waste over your fence into a farmer's field or horse paddock, however, it is illegal, and you could face prosecution. Green waste can be **extremely dangerous** to horses and animals resulting in life threating conditions such as colic, stomach rupture or laminitis.

Green waste can cause serious damage to farmland. There are many chemicals that arise in garden waste that result in long lasting damage to the soil and ultimately, food production.

Avoid a fine. Put items in a bin.
