1. Introduction to Working Group

Bob Kilvington (BK) gave an overview of the background to setting up the meeting including the formation of a working group culminating in a positive response from 21 out of 28 Parish/Town Councils. BK advised the importance of the Chelmsford Association of Local Councils (CALC) is to engage, as well as gaining support from EALC and Chelmsford City Council. Melanie Williamson (MW) advised it is important encourage Councils to share lessons learned and to network.

2. EALC Presentation

Mike Eldred and Charlene Slade gave a presentation on EALC and the support they would be able to give CALC. The presentation will be e-mailed to attendees. A question and answer session followed.

3. Proposal to form CALC

A ballot paper vote took place as a resolution to establish the Chelmsford Association of Local Councils. This resulted in 17 votes for and 0 votes against. The formation of CALC was confirmed.

4. Election of Officers

Confirmation of two members to attend EALC Executive Committee: Bob Kilvington and Joe Parsad to attend the EALC meeting on 10th July. Attendance at the next EALC meeting on 4th September, to be discussed at next Committee meeting.

Confirmation of Clerk: Louise Flavell, proposed by Bob Kilvington and seconded by Melanie Williamson and agreed unanimously.

5. Agreement of Constitution

The Constitution and the name of the Constitution was agreed as Chelmsford Association of Local Councils (CALC), proposed by Martin Cross and seconded by Melanie Williamson and agreed unanimously.

The Constitution will be discussed further at next Committee meeting.

The aims and objectives of CALC were discussed and the following items were proposed:

- LGR – the need to be more proactive and to work closer with EALC to affirm the positioning of Parish and Town Councils.
- The need to be heard – Parish and Town Councils have a meaningful voice and it is important to demand Chelmsford City Council and Essex County Council/Unitaries listen to them. Council members are there to make a difference to their communities.

Action: Committee to draft an Aims and Objectives document/set of questions for discussion at a virtual meeting in August.

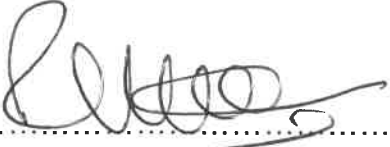
6. Future Meetings
