The white gates proposed either side of the road on the Chignal Road supportive but concerned about the cost of £10,500. The gates will be a deterrent for speeding drivers. This should be of utmost importance. Could this estimate and the contractor be challenged?

Challenge on the white gates and an objection to the cost. Request to consider a consultation.

Can we get more support from the residents and wider afield? Previously this has been undertaken with a good response.

If LHP are placing road traffic indicators, will they differentiate between road users? Yes, the traffic survey does note the different axle weights.

Hollow Lane - closures and 40mph approved and it is planned for October half term.

Village Gateway – LHP - All funds are used up this year if wanted this year, the only way to do it is to fund. As a total request or match funding, it would need to be a candidate for next year. There are 5 ECC, 5 CCC, and 1 EALC (PC) reps on the Chelmsford LHP, all fighting for their divisions! With requests at 10 times the available budget, match funding requests get a more favourable view as they clearly show that the requester is committed to the scheme. My understanding is that it will be £10,500 for gates either side of the area – with such gates having a left and right side – so four separate structures. The design stage would finalise this as it also includes checking land ownership, permissions, utilities. Note this is an estimate – so could increase or decrease.

30mph – The application is ready to be submitted, once you approve at your PC meeting **Home to School Transport** – ECC are only responsible for transporting entitled children to school for free. Entitlement is Govt set criteria where a child under sixteen has the **nearest** school is more than three miles away, or it is less than 3 miles but there is not a safe walking route.

Chelmer Valley High School (CVHS) has been served by a coach company for over 5 years, but this year competition from cab companies has brought in alternatives to larger school buses. The CVHS contract was still won by the coach company, but at a lower price. Consequently, the coach company has had to replan routes and vehicle sizes and the number of unused seats, which can be sold to non-entitled children, is less.

ECC has not changed its position – it continues to meet its obligation to transport entitled children, but the sale of unused seats beyond this is a commercial decision by the coach operators.

It is likely that if the coach company had not won the contract, there would not have been any unused seats for sale.

However, we have been in ongoing contact with the coach operator to try to maximise the number of seats for sale. The net result is that the CVHS contract accommodates 158 entitled children who have applied (contractual capacity was 170) and the capacity has been enhanced to two hundred by allowing standing and conditional offerings, meaning forty-two seats were available for sale. It is believed that this means that the Chignals, Boreham, Leighs, Great Waltham non-entitled children have been accommodated.

To address another misunderstanding, CVHS does not have a catchment area (formally known as defined priority admissions area). The school has listed the primary schools that have a relationship with Chelmer Valley High School as part of the River Chelmer Partnership.

Parish area: Chignal

Feedback from informal consultation: no change necessary. Feedback from first formal consultation: forty electronic responses received advising they are from this parish, although some were from the neighbouring unparished area of the City Centre. Most were supportive of retaining the status quo. The following comments were received: One respondent felt the Little Hollows development was separate from the rest of the parish and should therefore no longer be part of the parish. However, several

respondents from that area advised they feel more part of Chignal than the neighbouring City. It appears a level of concern has arisen in this area that the city would 'swallow up' Little Hollows, and a number of respondents from that area advised they wish to remain in Chignal parish. One respondent advocated for the abolition of the parish council. Several respondents advised they would prefer to be part of the Chelmsford parliamentary constituency, although this is outside of the remit of the CGR (and is the responsibility of the Boundary Commission for England).

<u>Development</u>: no significant new housing development is noted within the parish, other than in the Hollow Lane area.

Assessment: the development around Hollow Lane, Dogrose Close, Foxglove Avenue and surrounds is currently divided between Broomfield and Chignal parishes. This is unlikely to reflect the interests and identities of the local community. As there will be no vehicular access from this area to the rest of Broomfield, it would not be logical for this community to be included within that parish. That leaves two options – to include the area within Chignal parish, or to amend the boundary such that it becomes part of the unparished area. Some submissions were received from residents in this area not wishing to be part of the unparished city centre. However, Members at the Connectivity and Local Democracy Working Group noted that the number of properties expected in this development site would, if they became part of Chignal, comprise around two-thirds of the total number of households and would therefore change the nature of Chignal. Access is primarily to the south, into the unparished area of the City Centre, and the development is considered more likely an extension of the City Centre rather than an extension of Chignal. As such, the recommendation is that this area should become part of the unparished area.

Draft recommendation: given the current community governance arrangements meet the statutory tests, there is no expected major new housing development that would disrupt those arrangements, and no identified support for changing arrangements, we recommend:

Amend the parish boundary such that the Hollow Lane area becomes part of the unparished city centre area, as shown in the map below. No change in electoral arrangements, so retaining a parish council. Area CB is currently split between Chignal and Broomfield. The proposal is that this becomes part of the unparished City Centre.

Governance arrangements: Electorate 396. Changes in electorate due to proposed boundary changes – 170 to city centre Proposed electorate 226. Current number of parish councillors seven. Ratio (electors per parish councillor, rounded) as NALC recommendation (1988 guidance). Notes on recent elections. No recent contested elections. One unfilled seat in 2019 Proposed number of parish councillors 7 – no change

Draft recommendations: (1) No change in parish boundary, other than as noted in Broomfield section of this report. (2) No change in parish name. (3) No change in the number of parish councillors

Concerns raised about speeding, road use, danger to cyclists and walkers – 25 houses in Chignal Smealey area affected. Resident witnessed a near miss incident between a cyclist and van on Chignal Road. Road Traffic levels are higher than previous years. Volume high on Chignal Road to Chelmsford. Examples provided of White Gates fitted in other areas, (not Essex) that cost £2000 for 2 pairs of gates. Offer to fit them by a member of the public. Confirmation that White

Gates reduce speeding but do not eliminate it. The amount of rubbish collected every week on the road to Chelmsford is up to a black bin bag.

Parish Council Survey on list of priorities for community projects: concerns about the Priority that may be given to the White Gates.

Change in the Parish Boundary. Little Hollows residents have been contacted directly by the City Council. New suggestion to move the Parish Boundary to include Little Hollows but not the Persimmon part of the Parish. Field opposite Little Hollows is not allocated for housing in the approved Chelmsford Local Plan.

Meeting with Highways Cabinet Member

I have arranged for the Highways Cabinet Member to meet 5 of my 10 Parish Councils on 19th Nov (GW, LW, Chignal, Writtle and Broomfield). These 5 have the most queries on Highway maintenance and LHP requests submitted. The meeting will look at the gap between PC/public expectations and Highways delivery and what can be done about it.

White Gates

Promote at the LHP meeting on the 17th. Cost covers Traffic Road Orders, Utility searches and approved contractors. Essex does not support a self-installation model.

The website also contains information on the types of schemes in a series of Members' Guides, including the required criteria. My approach is to take recommendations from the PC, rather than individuals, and support ones that align with the objectives and criteria of the LHP.

It should be noted that the LHP is not an enforcement agency and speeding issues, or other traffic violations, need to be reported to the police via 101 or report on line https://www.essex.police.uk/ro/report/

You can also report it to SERP and ask them if they will arrange some speed traps https://saferessexroads.org/

The 30mph request has been submitted, but has not yet been validated, so doesn't have a reference number

40mph and closure Hollow Lane:

The 40mph on Woodhall Hill (sic) has been partially implemented. Hollow Lane closure is still awaiting delivery of the gate.

Post

Contacted CEO of Royal mail to raise concerns with the situation covering a lot of the Chelmsford area. Covid and staff issues potentially. The postman has to sort his own mail before doing the delivery.

ii. Chelmsford City Councillor Report

Boundary Changes:

City Council Parish Boundary change recommendations were approved to go to consultation at the City Council meeting of 22nd Sept. All residents potentially affected will get a written correspondence and invitation to comment. Others who are not directly affected (i.e. not changing parish, even if the parish is affected) can still comment via the website, but they will not be individually contacted.

Bin Collections

So far bin collection has not been affected by the national HGV driver shortages.

Covid

Post Covid car park income recovery is not going too well. Whilst short term retail car parks have returned to 80% of pre-Covid levels. Park & Ride and long term commuter car parks are around 20%.

2021/353 Chelmsford Governance Review: public consultation

Parish area: Chignal (Parish Council)

Chignal is one of the parishes where the boundaries are proposed for change: removing the new housing areas of Little Hollows and a part of Copperfield Place from Chignal parish to join the unparished built-up area of Chelmsford. Individual letters explaining these boundaries changes and asking for views have been sent by the City Council to residents in the affected areas bordering Hollow Lane but it does not appear that residents in the rest of the rural parish have received this direct communication.

The consultation asks 3 simple questions:

- O Do you agree with the change?
- O Why do you feel this way?
- Tell us anything else to help make a final recommendation for this area?

The consultation questionnaire can be completed on-line at www.chelmsford.gov/cgr before 30th November 2021

Residents of Mashbury are also being asked whether they would wish to continue as a Parish Meeting or join with Chignal Parish.

Recommendation

That the Parish Council informs the City Council that it does not agree with the proposed removal of the new housing areas bordering Hollow Lane from Chignal Parish and that it is prepared to consider amalgamating with Mashbury to improve governance arrangements for that community.

Parishioners in Little Hollows have made it clear they wish to stay in the Parish. The Residents of the Persimmon houses in the Parish are not fully occupied and we do not know their preference.

We feel strongly that the northern boundary tree buffer which the Parish Council has proposed should be shown clearly on the plans accompanying this application. We should like to be able to comment on a detailed landscaping plan that includes this tree buffer before permission is granted for this development.

Recommendation

That permission should be conditional on the inclusion of a substantial tree buffer along the northern perimeter of the site as described above in accordance with landscaping provisions agreed in the approved Masterplan. This should be of sufficient size to mitigate the impact of this urban intrusion on the rural landscape of Chignal St James or to provide a meaningful corridor for wildlife.

2. 21/05254/TPO. The Old School Mashbury Road Chignal St James Chelmsford.

Resolution

The mature trees in the garden of The Old School are significant and attractive landscape features which can be seen from the adjacent playing field and village hall. Six of these trees are deemed to have outstanding or special amenity value and have been given special protection through the attachment of Tree Preservation Orders. This application proposes significant reductions in size to three of the protected Limes T1, T2, T3.

The applicant proposes to reduce the canopy of the Lime T1 at the front of the property up to 6 metres. It is considered that this scale of reduction is too drastic and could eventually kill the tree. The proposed reduction of the Limes T2 and T3 up to 4m is considered unnecessary and would have a detrimental effect on the health and appearance of the trees.

Recommendation

Lime T1 should only be reduced through an overall gradual crown reduction of 20% with a possible crown lift and epicormic growth removed. Any dead, diseased or dying wood to be removed from the upper canopy. The proposed reduction of Limes T2 and T3 should be refused. The trees should be left alone.

Other Planning Information

Update from Planning Officer on Barn Conversions, west of Beaumont Otes Cottage

Some works have therefore begun on site. The conditions relating to large scale details and materials have yet to be discharged. Any public health nuisance issues on the site can be raised with the City Council's Public Health and Protection teams.

Report on the Community Meeting on Climate Change, 2 October 2021

19 people attended the Community Meeting from Chignal St James (8); Chignal Smealey (8); Little Hollows (2); Newlands Spring (1). Presentations were given by parish councillors on:

Climate change key facts and how they link to our daily lives;

Community renewable heating initiatives;

Individual actions that could make a difference;

Gardens, gardeners and the community orchard;

Parish-wide climate change mitigation projects.

A range of suggestions were generated by the break-out groups on community-wide and individual actions that could contribute to mitigating the impacts of climate change

1. Increasing bio-diversity and carbon capture

Tree planting: greatly appreciated that the parish has supported tree planting and happy with the way the council have looked after and watered the trees. Suggestion to plant some trees close to the gazebo on the playing field to act as shade in the summer.

Road verges: would like to see them left longer with wild flowers and not trimmed as often. Note: the Parish Council reached an agreement with the City Council and Essex Highways about 4 years ago to have a half cut of the verges in the spring to give the less vigorous wild plants a chance to flower in line with Plantlife's recommendations and road safety requirements.

Proposal to survey wild plants and wildlife in St Nicholas churchyard: funding would be available through the St Nicholas Bat Conservation project to carry out the survey and to produce an information board in the churchyard.

Community orchard: encourage more volunteers to help with the practical tasks of managing the orchard and wildflower meadow in a low carbon way. E.g., canvassing interest in a training session on using and maintaining an Austrian scythe to carry out the annual meadow cut.

Wildflower meadows: advice requested on how to establish and manage a wildflower meadow. Orchard Committee and Gardening Club could consider:

Organising practical demonstrations on ground preparation and seed sowing in the autumn in individual gardens and on the annual meadow cut and removing the hay in the community orchard.

Producing a guide on establishing and managing a wildflower meadow in printed form and on the Chignal website.

Soil protection: advice requested on the benefits and practicalities of sowing and managing green manures. Gardening Club could consider:

Sharing experience of sourcing green manure seeds, e.g., www.sowseeds.co.uk

Visiting members' gardens to see green manure plants growing.

Home grown food: share surplus with residents who may not be able to grow food themselves, such as elderly pensioners.

Gardening Club could consider working with the Friends of the Chignals and Mashbury Group to distribute surplus vegetables and fruit plus produce could be collected at the monthly Coffee Mornings.

Save seeds and distribute to residents.

Traditional ways of farming and gardening: research needed in the parish to learn how food was grown without chemicals and modern machinery. Many of the older properties were connected to farming and have an interesting history. Old field names are cultural indicators, such as "Empty Purse" behind St Mary's Cottage which records a time when surplus crops produced on this fertile ground were distributed to poorer residents.

2. Options for home heating and insulation (see attached Powerpoint presentation)

Group heat/ground pumps and solar panels: consensus to do a feasibility study (Phase 1) for parish wide application and also consider heating schemes in clusters rather than individually to benefit from economies of scale etc. Consult residents and invite interest in Chignal News.

Insulation of attics/walls: should also be considered to help with the effectiveness and efficiency of all the above projects.

3. Transport

Cycling and walking: consider ways of making cyclists and walkers feel safer on the parish roads and on routes into Chelmsford.

Cycle paths: check progress on the cycle path proposed on the west side of Chignal Road from Trent Road to Roxwell Road. <u>Note:</u> maps showing current cycle routes around Chelmsford can be printed from:

Traffic calming: continue with efforts to implement measures such as a new 30mph limit on Chignal Road and village entry gates

Electric Car Charging: advice on costs, community schemes etc

4. Keeping it Local

Promote local traders: decorators, electricians, gardeners, plumbers, general jobs – Chignal website, community page and Chignal news

From the County Council - Mike Steel

Highways Winter Service - from your Essex County Cllr, Mike Steel

Essex County Council (ECC) move into its Winter Service period from late October to mid-April (weather dependent!). During this period, they grit PR1s and PR2s (Priority Routes) – over 2,000 miles of roads carrying about 80% of traffic and accounting for 40% of the network. They also grit access routes to hospitals, fire and ambulance





stations, public service bus routes (where there are 4 or more a day – 5 days a week), other high-risk sites such as a severe gradient or higher than usual traffic levels, access routes to a settlement or parish of +50 households. Roads with schools are not necessarily included if they do not meet these criteria. Weather patterns over the last couple of decades have varied with mild winters before 2009 (so authorities reduced salt stocks). 2009 to 2013 saw some severe winters and salt demand soared.

Highways authorities need to predict usage and are applying smarter forecasting. They don't want to waste their salt stocks if the weather is good, nor overstock as it does deteriorate over time. They have switched to mobilising the gritters based on forecast road surface temperature rather than air temp. It does make a difference. Some roads hold heat for longer depending on location and composition so road temp can be different from air temp. Gritting does not remove snow! It is important to lay the grit down before the snow comes,



hence the importance of forecasting. ECC have 2 types of gritting trucks – the larger ones can cover 80km of road with a heavy spread, and the smaller ones 55km. They can cover more distance if the spread is reduced when less severe temperatures are forecast.

ECC collaborate with City Council/Parish Councils – they are all invited to join the salt bag partnership. This year we have 72 Parishes and District Councils signed up to organise teams of volunteers to clear the



snow and then apply salt/grit to areas of local concern, such as paths to schools and other important services not covered by ECC. 1 Tonne of salt is provided free of charge plus a support/training pack. I have been a volunteer for my local parish for many years and we have text group set up to get out when the weather deteriorates and we clear and grit the paths to the school, village shop and elderly residents' homes. What's happening at St Nicholas Church
