- Near Gardening Express car park bottom of the road seems to flood since the building of the car park. High volume of water in that area. Only seems to occur when there is rain, and this leads on to potentially frozen patches on the road.

2024/803 County and City Councillors' Reports.

Essex County Councillor Report – Cllr Mike Steel – Apologies –

Keep Essex Car Tax for Essex Roads

The greatest number of complaints, by far, are in relation to highway defects. Whilst highways (roads, pavements, overgrown verges and hedges, flooding, PROW maintenance, etc), affect everyone, it is allocated around 5% of the gross ECC budget.

Over three quarters of ECC budget goes on the mandatory Adult Social Care, Children's services and Education. Not everyone currently benefits from those services, but people need to be reassured that when they do need them, they will be able to access them!

As the demand for Adult Social Care, Children's services and Education services grow at a significant rate, the funds left for other services becomes less. It should be noted that the demand for SEN assessments has nearly doubled in the last 5 years, outstripping the availability of child psychologists to carry out the assessments.

It is not generally understood that Vehicle Excise Duty goes to Central Govt, whilst County Councils have responsibility for highways maintenance and the County Councils do not see the income. We often hear people saying, "I pay my road tax and expect the roads to be fixed". Well, it does not work like that! Vehicle Excise Duty collects £7.3Bn pa in the UK, which equates to about £300M from Essex vehicle owners, none of this gets returned to Essex. So, we have to do the best we can with the limited funds, which means prioritising according to safety, etc.

The ECC Conservative Group proposed a motion at County council meeting 10th Dec 24, to Keep Essex Car Tax for Essex Roads and calling on the Govt to add the amount paid by Essex residents to ECC's budget settlement for 2025/26 onwards and for it to be ringfenced for road maintenance. The motion was successfully passed, and the request will be sent to the Chancellor of the Exchequer, the Secretary of State for Transport and all Essex MPs.

Love Your Bus

Deadline for applications is 14th Feb 2025

It seems to be offering Town and Parish councils the ability to run their own bus services – either individually or jointly between several councils. The grant is purely for revenue, and does not include capital – i.e., does not appear to include any capital purchase.

I struggle to see the logic of PCs running a bus service, but there might be some rural PCs that feel the current services fall short and they could run one themselves. Pleshey might be a good example, where there are just two services a week. However, Digigo covers much of my division, including Pleshey, so it is hard to see the need. The larger parishes in my division, such as Great Waltham, Little Waltham, Broomfield, Writtle, have reasonable main bus services, so difficult to see how this could help!

However, I am open to debate and will support any bid from any of my PCs.

An alternative proposal might be that the PCs write to Chelmsford City council and ask them to consider making a bid for the Chelmsford area and the locations that have shortfalls. However, I do see several gap fillers such a Digigo and Community Transport, so I doubt there is a large demand for additional services.

It offers a range of Local Govt reforms which ties into the number of devolved powers from Central Govt. it would be fair to say that it encourages the mayoral approach to a unitary council. For Essex, which would mean splitting it into 3 or 4 unitary councils that then encompass the County level and District level.

The leader of ECC is keen to bring decision making and power closer to the people therefore Essex will be a front runner for devolution. County Councils have until 10th Jan 25 to submit a proposal which in our case, needs to reach agreement with Southend and Thurrock as well.

An ECC extra-ordinary meeting on the 10^{th of} Jan, agreed to make a submission to Central Govt, to be included in the next tranche of Devolution and LGR. This requires that the County Council elections of May 25, are delayed for at least one year. Central Govt will respond by 24th Feb as to whether this has been accepted, and elections are delayed.

Whilst I have many reservations about the whole concept of such reforms, the over-riding issue is that it is clear that Govt will impose a solution if we do not manage it ourselves – therefore better to be in control.

I voted to make the request to Central Govt. Ultimately, the decision to make the proposal, rests solely with the leaders of ECC, Thurrock and Southend, but the leader of ECC wanted to debate the issue at the meeting of 10th Jan and give all ECC Cllrs the opportunity to express their views. The result was that the members voted to endorse the request to move forward and delay elections.

Highway defect reporting

Residents and road users have more options when reporting road defects following a major update by Essex Highways.

The update comes as users will no longer be able to raise issues via third-party sites, such as Fix My Street, from 1 January 2025 due to the lack of detail they provide inspectors.

The 'Report It' webpage by Essex Highways has been tailored to capture all necessary information. This now includes different types of emergencies and if issues have worsened over time.

The '<u>Track It</u>' webpage lets users see the progress of reports, from inspection to repair, and whether similar issues have already been raised.

Issues logged through third-party platforms are often duplicates of reports already received via Report It, or unrelated to the roads managed by Essex Highways.

By moving exclusively to Report It, Essex Highways can ensure the 50,000 reports received annually are managed in one place, resulting in a faster and more transparent process.

There is also a major cleansing project under way – to clear outdated enquiries on the system. If you look at Track-It, you need to understand the difference between Enquiry References, and Defect Numbers. The former are the problems logged by the public, which when inspected, get converted to a Defect Number. In many cases there are several Enquiry References for one fault, and the process is that when the inspection occurs, several Enquiries will be closed and one Defect Number raised. But it does not always work like that – so a data cleanse project is currently underway.

Highways' Highlights Nov/Dec 24

We have been hit with a couple of major storms over the last few weeks (Bert and Darragh). Highways responded to 301 emergency calls on seventy-nine tree issues and 222 flooding issues. In November, we fixed 2,254 potholes, 942 pavement defects, cleared 9,994 drains and fixed 1,228 streetlights.

As you know, I have made extensive use of the Members' Highways Initiative which enables County Cllrs to identify road and pavement issues which matter most to residents. I have submitted fifty-nine separate defects, which will keep the extra team busy until next year, so I have pretty much used up (over-used) my quota.

However, a new "Winter Damage" Members' scheme has been introduced – it appears that not all Cllrs have been as proactive as me in using the Members' Initiative and there is spare capacity which is being offered for defects that that have deteriorated due to winter conditions. I have already submitted some defects for this scheme. Let me know if you have any that might fit – existing track-It ref and photo please (if safe to take).

I say this often, but the problem is that more than three quarters the gross ECC budget goes on Adult Social Care and Children's services, so there is little left for all the other services, including Highways, but I do try to make the most of any initiatives!

Chelmsford Northeast Bypass construction to begin early next year.

The first phase of the Chelmsford Northeast Bypass will be constructed by Octavius Infrastructure Limited. Works are scheduled to begin in early 2025 and finish by spring 2026.

The bypass, along with the new Beaulieu Park Station, will provide vital transport links to support planned housing and economic growth in the north of Chelmsford.

The first section of the bypass, known as 1A, will connect to Beaulieu Parkway in the south. This will provide access to the A12 at Boreham Interchange via the Beaulieu Parkway Bridge.

1A will also join a new link road to the north – being built as part of the Chelmsford Garden Community – and Wheelers Hill roundabout on A131 Essex Regiment Way.

The first section of the bypass is mostly funded by the government through the Housing Infrastructure Fund (HIF). Funding is also being provided by Essex County Council, alongside developer contributions through Chelmsford City Council. The HIF was secured as a result of plans for the Chelmsford Garden Community. When complete, the garden community is expected to provide over 10,000 new homes and 5,000 sq. m of employment space. This is in addition to green space, schools and other facilities. The HIF also includes commissioning Network Rail to build the new Beaulieu Park Station, which is due to be completed next year.

Pylons

Whilst our MP has been elevated to leader of the opposition, I wanted to make sure that she is still supporting local issues as our MP. So, Kemi joined me on a cold and windy Friday (22nd Nov), and landowner in the" Waltham Gap" along with one of the farmers for that area. We jointly continue to oppose the proposition of pylons spoiling our countryside, along with Essex County Council. We are pushing for alternatives but recognise that the most viable alternative would be underground AC through the Waltham gap and continuing to the West of Chelmsford. Whilst this might cause much disruption in the short term, it would be better in the long term.

Election

As reported last time, due to the death of Cllr Ian Grundy (both ECC and CCC), ECC have received a valid requisition for a by-election to be held for the Stock Division. The election returned Cllr Sue Dobson (Conservative) to the position.

LHP:

The Village gateway was scheduled for implementation in Q3 – Oct to Dec 2024. There was requested to add 40mph on the road and additional roundels, requiring a top up of £3,500 which was sanctioned by the LHP committee. I note that some 40mph painted on the roads have been done and maybe some roundels. So, I am not sure of the status of the gateways and have made enquiries – and will update the report if I get anything.
