### **Mashbury Community Governance Review**

For the last few months, people living in Mashbury have been discussing how their community will be governed in the future. Following receipt of a petition from over 50 Mashbury electors requesting a review of governance arrangements with a view to amalgamating with Chignal Parish, the City Council has put forward seven options for public consultation. The aim of this review is to ensure that governance within the Mashbury area reflects the identity and interests of that community and is effective and convenient.

Chignal Parish Council has already indicated that it would welcome an amalgamation with Mashbury as there are many historic, social and economic links between our two communities and several shared amenities. Mashbury residents already enjoy the benefits of using the village hall and the community orchard in Chignal St James and receiving 'Chignal News'. Together the two areas form the Parish of the Church of St Nicholas in Chignal Smealy. Several Mashbury residents are active supporters of clubs and societies, most of which meet in the village hall and participate in events such as the monthly coffee mornings held there and in the United Reform Church, the Fête and other events organised in Chignal.

Chignal Parish Council will consider its formal response to the public consultation on the Mashbury Community Governance Review at its meeting on 9<sup>th</sup> March when Chignal residents will be able to give their views on the options during public question time.

By way of background, particularly for our Mashbury readers, here are some of the things that a parish council does for its community.

A parish council is a local authority that makes decisions on behalf of the people in the parish. It is the level of government closest to the community. As it is the authority closest to the people, parish councils are invariably the first place people will go with concerns or ideas. For this reason they are a vital part of any community.

Chignal Parish Council meets every two months and considers planning applications and any other matters referred to it by local residents, Chelmsford City Council, Essex County Council and by central government. Parish Council meetings are open to the public and there is an opportunity at the start of the meeting when members of the public can raise concerns and ask questions. There is also an annual meeting, (next one is on 9<sup>th</sup> March) to which all parishioners are invited to attend and local clubs and groups, (many involving Mashbury residents) report on their activities. All meetings are advertised on the parish council notice boards. Residents can bring to the attention of the parish council anything that concerns them, either directly or through the clerk, Mrs Janet Mills. If matters raised are not the responsibility of the council, the clerk can bring them to the attention of the proper authority. (continued on page 6)

### Mashbury Community Governance Review Continued

The Parish Council has a wide range of powers related to local matters:

- Managing community amenities and services, such as the playing field, community orchard, notice boards, phone box, village website and newsletter, neighbourhood watch;
- Monitoring the performance of local public services, such as local bus services, public rights of way, roads, drainage, signposts, community policing, domestic refuse collection, litter picking, mobile library etc.
- Championing community interests and supporting local groups and village events;
- Liaising with local private businesses whose operations may impact on the parish, such as gravel extraction, waste disposal, telecommunications, power supply and agriculture;
- Supporting community led plans, such as the Chignal Villages Design Statement and the emerging Parish Plan;
- Securing external funding to support a wide range of community projects, such as the
  establishment of the community orchard and banners to welcome the 'Tour de France' and
  providing small grants to local organisations, for example, part funding of the recent tree work
  in St Nicholas churchyard.

The council also has the power to raise money through taxation, the precept, to cover the cost of: overheads such as insurance, employing a part-time Clerk, hiring meeting venues, printing; the management of community amenities and services such as the playing field, website and newsletter; and, offering small community grants. The precept is the parish council's share of the council tax. The precept demand goes to the billing authority, the district council, which collects the tax for the parish council.

As you can see from the above, parish councils make all kinds of decisions on issues that affect the local community. Councillors are accountable to their electorate and can raise concerns on their behalf. There is another important way to influence what goes on in your area by participating in community-led planning such as a Parish Plan which is the subject of another article in this edition of 'Chignal News'. This is a unique opportunity for both Chignal and Mashbury residents to come together to identify issues and set priorities for future action.

Come along and see for yourself on Saturday 14th March, 10.00 – 12.15 at the village hall.

### **County Council Budget 2015/16**

The proposed Essex County Council budget will freeze Council Tax for the fifth successive year. Some of the key elements of the budget include:

- Starting a five-year programme to develop flood defences.

#### 1. **Apologies For Absence**

#### 3. The Minutes Of The Meeting **10 November 2014**

Were approved and signed by the Chairman as a correct record.

#### **Matters Arising From The Minutes** 4. a)Notice Boards.

Cllr Towns reported that a contractor had reviewed the 4 notice boards and had submitted a quote of £800.00 to put the boards in good order. Other contractors had been contacted but no other quotes had been received. Members agreed that other quotes were required before a decision could be made.

#### b)Governance of Mashbury

Mrs Moira Tarrant had been invited to update the meeting with the latest information. It was reported that a petition regarding the governance of Mashbury had been received by CCC. The first choice of voters in the petition was that Mashbury amalgamate with Chignal Parish Council. In accordance with regulations a three month consultation, period would begin on 12 January 2015. Each household would receive a letter setting out the process and the seven options available. The outcome of the consultation, to be implemented in April 2016, would be ratified by full Council of CCC in July 2015. Mrs Tarrant was thanked for the report. The matter would be included in the next Chignal News

Letter. Residents were asked to contact. the Clerk with their views.

### **Heavy Lorry Movements**

Great Waltham Parish Council had recently formally considered whether they should jointly investigate whether a weight restriction should be introduced on Breeds Road. Members agreed that they would not support a weight restriction application preferring to work closely with the lorry companies to solve issues as they arose.

### d)Parish Plan

The PC was to work with the Rural Community Council (RCCE) for Essex to draw up the Parish Plan. The PC had recently been advised that Central Government was to withdraw funding for Community Councils. Cllr Linda Nelson raised and Cllr. Martyn Towns seconded a motion that The PC should support the RCCE by lobbying Central Government to continue to fund the organisation. With no objections the motion was carried. Given the support already shown by local residents of Mashbury to join Chiqnal Parish, it was agreed that it would be appropriate to invite them to join Chignal residents to attend a workshop, facilitated by the RCCE to launch the preparation of the Parish Plan. Two meetings had already been held with representatives drawn from local clubs and groups to explore ways of co-ordinating events and activities in Chignal and Mashbury. Members of this events co-ordination group would also be invited to take part in producing the Parish Plan. It was not considered necessary to delay the plan preparation process until after the consultation on the Governance was completed. The RCCE would be asked to suggest some dates for an inaugural workshop and in the meantime local research to gather facts and figures and background work would be undertaken. The City Council would also be consulted about the Parish Plan.

### e) Gardening Express

The PC had been contacted by the agents of the owner with a view to arranging a meeting with PC Members to discuss the development of the site. Meeting arrangements would be made shortly.

### f) Persimmons Homes Planning Application

A statement of common ground with Broomfield PC and Newlands Spring Residents Association had already been submitted to CCC with the proviso that revisions may be made following consideration by Chignal PC at their meeting on 12 January. The Parish Council was now to submit its individual comments to CCC. A Discussion Paper giving a Summary of what was being proposed by Persimmon Homes on land north of Copperfield Road (planning application 14/01672/FUL), had been previously circulated. The meeting was asked to review the document and provide any further comments for inclusion. The following response would be sent to CCC.

Chignal Parish Council Comments, 12<sup>th</sup> January 2015

### 1.1 Background

In addition to the points raised jointly with Broomfield Parish Council and the Newlands Residents Association in a 'Statement of Common Ground' which has already been submitted to the City Council, Chignal Parish Council would like to make some specific comments in relation to the above planning applications. We reserve the right to comment separately on Application 14/01672/OUT at the detailed application stage.

### 2. Road Safety

2.2 The 'Statement of Common Ground' mentioned above, focusses on the anticipated impact of the construction of a new access road and on the additional pressure that traffic from residential

development on land north of Copperfield Road will put on the existing local rural and residential road network. A growing number of vehicles appear to be using our narrow country lanes, using the northern section of Chignal Road, Breeds Road and Larks Lane in Great Waltham to avoid driving through Chelmsford. The additional domestic and commercial traffic that will be generated from this residential development and from the adjacent site that will be served by the new access road will exacerbate problems such as verge damage, increased maintenance requirements and increased safety concerns.

2.3 In particular, we have increasing concerns about safety at the junctions of Chignal Road with Breeds Road in Chignal Smealy and with Mashbury Road in Chignal St James. We believe that investigations should be undertaken to identify the specific problems for drivers using these junctions and that resources need to be allocated to implement appropriate solutions that would allow vehicles to enter and exit Chignal Road more safely.

### 3. Public Rights of Way

3.1 The public footpath 45 in Chignal Parish should be maintained appropriately within the development site. This right of way is not shown on the Indicative Landscape Masterplan (JBA 10/03-04) and we would expect this omission to be to be rectified in any detailed Planning Application for this site.

#### 4. Public Question Time

- a) A resident raised concerns regarding planning application 14/01672/FUL In particular the proposals regarding the traffic rights of way at the proposed changes to the junction of hollow Lane and Chignal Road. Increasing concerns about safety at the junctions of Chignal Road with Breeds Road in Chignal Smealy and with Mashbury Road in Chignal St James Chignal Road were also raised.
- b) A resident was advised that organisers of running and cycling events which frequently came through the village, were not required to have formal permissions or give forward notice of events.
- c. Concerns were again raised that no action had been taken by the Highways Department to address the amount of surface water on Mashbury Road near to sharp bends by Pieces Cottage and the 3 Elms Public House. Cllr John Aldridge agreed to take up the matter.
- d) Concerns were raised that the Highways Department had failed to find and inspect and resolve a problem with a large manhole cover on the main carriage way outside Stevens Farm barns. It was reported that the manhole cover lifted from time to time due to the pressure of the blockage. Cllr John Aldridge agreed to take up the matter.
- e) With regard to the issues of large delivery lorries associated with Gardening Express a resident shared observations that Large Lorries were continuing to unload and then turn around by The Green at unsocial hours, ( around 9pm on Saturday evenings and at 7am on Sunday mornings).

#### 5. Chairman's Report

a) The Chairman was pleased to announce that work to improve 'passing places' in Chignal Smealy was progressing following a site meeting with County Highways involving local residents in December. Local land owners would be contacted regarding the proposals shortly: the work would begin in March.

Aldridge for his assistance in the matter.

The meeting was reminded that this was an election year. CPC currently had seven councillors, but there might be one or two vacancies in the near future. The Chairman asked for those interested in becoming a Parish Council councillor, to put their names forward to the Clerk. An article asking interested people to nominate themselves would be placed in the next Chignal News.

A note of thanks was given to Cllr.

- 6. County And City Councillors' Reports
  Cllr Nicolette Chambers informed the meeting as follows:
- a) Cllr Chambers agreed to represent Chignal Parish Council with regard to planning Application No.: 14/01672/FUL and 14/01672/OUT which was to be considered at the CCC planning meeting to be held on the 20 January.
- b) Cllr Chambers would be pleased to assist Mashbury through the governance process and procedure.
- c) A prestigious community evening was to be held on 13 March as part of the Mayors Events. Parishes could nominate a member of their parish to receive recognition for their good works within the community.

### Cllr John Aldridge informed the meeting as follows:

- a) Further to a Government review ECC would be receiving £49M less central funding than last year. There was cautious optimism that changes to the way that existing services were being delivered would prevent any reduction in services to the elderly or vulnerable.
- b) ECC would however be receiving an additional £50M for schemes to improve the Harlow stretch of the M11 and for Dualling of the A120 between Braintree and Marks Tey.
- c) Writtle PC was hosting an evening meeting with Police Chief Inspector Cook regarding the reduction of PCSO's level of policing in village communities. Cllr Middleditch agreed to attend and Cllr Philpot would be informed of the meeting.

- d) ECC was not receiving its fair share of funds from Central Government. Work continues with regard to seeking limited Devolution.
- ECC would be hosting events with e) schools related to the 800 year anniversary of the signing of the Magna Carta.
- Response to the Government f) consultation on Gypsy and Traveller Sites was to be published in the summer.

#### 7. **Community Games**

Essex County Council 'Active Essex' funding was available to parishes to stage sporting/cultural events between April and September 2015. Cllr Middleditch agreed to develop some ideas and if appropriate, progress an application.

#### **Parish Cleansing Days Parish Litter** 8. **Pick**

Cllr Feltwell agreed to progress the application for parish cleansing days. It was agreed the parish Litter Pick would take place on Saturday 21 March 2015. The Clerk would look into whether the Parish could be supplied with 10 litter picks that could be held permanently within the parish.

There is no indication in the application that the tree is damaged or diseased or that it is causing harm to the property. Given the considerable wildlife and amenity value of this oak and the clear guidance on tree preservation provided in

### Would you like to become a Chignal Parish Councillor?

In May 2015 we will elect up to seven councillors to represent the parish for a maximum of four years. Some existing councillors may choose to stay and stand for re-election but it is likely that that we shall have some vacancies to fill.

### Why become a Parish Councillor?

There's more to being a parish councillor than sitting in meetings in the village hall.

Many people seek to sit on the council because they want to give something back to their community: they are proud of it and want to protect its interests or help bring about change for the better. They wish to speak for the residents and make sure their voice in heard in any important decisions affecting the parish. Basically, they want to help. Their job is therefore to be active in the community, know what local people's views are and faithfully represent them to the parish council.

By becoming a parish councillor you become someone your community will look to for help, guidance and support. Seeing your community change for the better, as a result of decisions you have helped make, is something that can give you a sense of achievement.

### What decisions do Parish Councils make?

Parish councils make all kinds of decisions on issues that affect the local community. Probably the most common topics that parish councils get involved with are planning matters (they are statutory consultees), crime prevention, managing open spaces and campaigning for and delivering better services and facilities. It's true to say that on their own, parish councils have limited powers to make decisions. But they do have the ability to negotiate with, and the power to influence, those other organisations that do make the final decisions (such as the City Council, County Council, police etc).

In this respect parish councils are extremely powerful. The organisations that make the final decisions know that a parish council gives the best reflection of how a community feels about something, and its views will be taken seriously.

### How much time does it take up?

Chignal Parish Council has a full meeting every two months in the village hall in Chignal St James to which members of the public are also invited. Meetings usually start at 7.30pm and may last two or three hours, depending on the agenda. In addition to the regular meetings, councillors may be required to attend other meetings representing the council: for example acting as a representative on an outside body, community activities or helping develop a new project. Such meetings don't happen every day, so it's not going to take over your life.

### Am I eligible to be a Parish Councillor?

First of all, you must be eligible to stand for election. To be eligible you must be 18 years of age or over, a British or Irish citizen, or a citizen of a Commonwealth or European Union country, and have at least one of the following qualifications:

- you are on, and remain on for the duration of your term of office, the electoral register for the parish, and/or
- you have occupied, as an owner or tenant, land or premises in the parish for the whole 12 months before the date of nomination and the date of the election, and/or
- your main or only place of work during the whole 12 months before the date of nomination and the date of the election is in the parish, and/or
- you have lived within 3 miles (4.8 km) of the parish during the whole 12 months before the date of nomination and the date of the election

The process of standing for election is straightforward. You need to complete a nomination form, which you can obtain from the Parish Council Clerk, and get two people to sign it in support of your nomination. You do, though, have to deliver it in person to the Returning Officer at the Civic Centre in Chelmsford, but it only takes a few minutes to check the form and confirm that it's alright for you to stand. For the elections on 7 May, nominations can be delivered on any working day between 24 March and 4pm on 9 April.

If you do become a parish councillor you will have to sign up to the Code of Conduct.

If you feel that you have something to give to your local community, why not stand for election to the Parish Council and help shape the future of Chignal? The best way to find out what it's like to be a parish councillor is to talk to someone who's doing it now. Come along to the next parish council meeting on 9<sup>th</sup> March, or speak to one of our councillors and find out what they think of the job.

#### Not being busy for Lent

At Corpus Christi college, Cambridge there is a clock made by John Taylor in 2008. On the top is a chronophage, a time eater, a locust type insect that gobbles up time, eating the passing seconds. It winks from time to time with satisfaction as it eats.

I wonder if you are giving anything up for Lent, or may be you are taking something on. When I've told people what I'm giving up for Lent they laugh and say good luck or how are you going to do that? Yet what I am giving up is pernicious and consistently takes me away from God and from people, persistently takes me away from what I need to focus on, where I need to spend my time.

What I am giving up for Lent is being busy.

So how can I do my job with 3 rural churches and 2 parishes and 2 church schools without being busy? When a group of vicars get together you can guarantee that they will moan about being busy, being too busy. But this isn't a problem just for ministers, it's a problem for so many of us, Mums, people working long hours in their jobs even retired people are busy and tell you they don't know how they fitted in work and that their diary is full. Many of us are running faster and not keeping up. There is more to do than time to do it. The faster we go, the worse it seems to get. The more we do the more is expected of us, the more we expect of ourselves.

So when we say busy what do we think of? Important? Wanted? Capable? Popular? efficient Or could busy mean self-important? Unable to delegate or work as a team? Not trusting others and not trusting God? Micro managing.

Eugene Patterson says: The word busy is the symptom not of commitment but of betrayal. It is not devotion but defection. The adjective busy set

as a modifier to pastor should sound in our ears like adulterous to characterise a wife or embezzling to describe a banker.

Tough words. Not just for us ministers but for all of us.

Stephen Cherry in his excellent little book Beyond Busyness thinks busyness is a disease, that the world does not need people who are constantly hassled, anxious or busy.

The questions I am asking myself is what is busy like and what is its opposite? Trusting God with time as well as everything else?

How can I not BE busy? How can I know and live in knowing that I have enough time? That I am doing what is most important, what God is calling me to today, how can I grow in time wisdom? How can i know the right time for different things, not just being dominated by clock time

Knowing there is a time for everything.

Knowing that I can live a full life, that includes the things and people I love and still be an effective minister loving and leading

But this is relevant for so many of us.

Join me at this time in learning how we can be time wise together. If you put Great Waltham into facebook you'll find us and can join the game. I will be interested to know what you think, what you are giving up or taking on, or you can join in not BEING busy.... we can share how we are doing.
