Listed black barns at Ulting Wick provide a backdrop for colourful and exuberant planting in 8 acres. Innovative spring planting, herbaceous borders, pond, mature weeping willows, kitchen garden. Drought tolerant wild flower meadow and front border. Woodland. New shrub and grass border. Many plants propagated in-house, for sale.

Thursday 18th **June, 7pm. "Washlands"**, Prayors Hill, Sible Hedingham, **Cost:** £5.50 per person including tea/coffee and cake (£6.50 non-members).

Washlands is an informal, tranquil garden of approximately 1 acre with good views over rolling countryside. Features include a horse pond. Wide herbaceous, shrub and woodland borders including roses and peonies. Many young and mature trees enhance the garden.

Our first stop is Otley Hall, a Grade 1 listed late medieval building with 10 acres of gardens. The garden tour includes parts of an important design by Francis Inigo Thomas (1866-1950), featuring an H-canal, nutteries, croquet lawn, rose garden and moat walk. In addition, there are historically accurate recreations designed by Sylvia Landsberg, author of The Medieval Garden. These include an orchard, a herber, and a knot garden.

At our February meeting Angus Wardle, who is a buyer at The Wine Company in Colchester, gave a presentation of wines from the Hispanic World. Angus proved to have an excellent knowledge of this topic and gave a highly informative and entertaining talk. We sampled three wines from Spain, two from Chile and one from Argentina. All the wines were favourably received and the general consensus was that the stand-out ones were an Albarino from Spain and a Malbec Reserva from Argentina, the latter in particular representing excellent value for money.

In March, Sam Brown from Vino Vero gave a presentation of wines from Eastern Europe. Sam is a young man who set up Vino Vero around two years ago and has built it up from a small beginning into a successful enterprise. Eastern European wines is a relatively new subject for our group and probably not surprisingly there was a mixed reception to some ofthose tasted. On the basis of wines ordered at the end of the evening the clear favourites were a nice Tokaji from Hungary and a Blaufrankisch from Austria.

Scarecrow Competition

Our new Scarecrow Competition will help to raise awareness of the fete this year and really brighten up the three villages. There is no set theme so let your imaginations run wild. Your scarecrow display should be in place, on private property and clearly visible from the outside of your property, by Saturday 30th May at the latest, and remain until Sunday 14th June.

There are two categories, one for children and one for either families or adults. Children's entry forms should state their ages and be signed by their parents/guardians.

RULES:

Scarecrows can be models, dolls, teddies, soft toys etc, as well as traditional scarecrows. There is no overall theme but entries must be in 'good taste' and suitable for a family event. Your display must be able to withstand all weather conditions and be securely anchored down. Your entry must be on your private property and maintained in good order and condition throughout the display period. You must have adequate liability insurance in place for the property in case of accidents or damage to third parties. If in doubt, contact your insurers.

You must take all reasonable care and responsibility to ensure the safety of the exhibit and people approaching to view it.

General road safety must be considered when determining the placement of your display. You may use props and accessories and your entry may be made up of multiple scarecrows. Each vote will cost 10p. The winner in each category will be the entry that receives the most votes.

A completed entry form and £3 fee for each separate entry should be delivered to Warwicks, Chignal St James (near the Three Elms PH) by Saturday 30th May. You can read the full rules and download entry forms from the parish council website at: http://www.essexinfo.net/thechiqnals/clubs-and-groups/village-hall/.

Please email a photo of your entry by Wednesday 3rd June to scarecrowcompetition@gmail.com and include your name and contact details. The judging will be by public vote by means of a photo gallery during the fete from 1pm and the winners will be announced at approximately 4.15pm. Each vote will cost 10p.

Chignal Parish Council Meeting 9th March 2015

Present:

Cllr Miss Lynn Ballard (Chair), Cllr Mr. Steve Middleditch, Cllr Malcolm Feltwell, Cllr Ms Linda Nelson (Vice-Chair), Cllr Mr. Martyn Towns, Cllr Mr. Chris Philpot

In Attendance:

1. Apologies For Absence Cllr Mr Andrew Jenkins

Cllr John Aldridge

2. Register Of Declarations Of Interests Cllr Philpot declared an interest in planning item 15/00046/FUL

3. The Minutes Of The Meeting 12 January 2015

Were approved and signed by the Chairman as a correct record.

4. Matters Arising From The Minutes

a) Parish Elections

The Clerk advised the meeting of the forthcoming parish elections and advised that interested candidates should contact the Clerk for the relevant nomination papers.

b) Governance of Mashbury

Members considered and approved the Parish Council's draft response.

c) Notice Boards.

Cllr Towns reported that two joiners had been approached regarding the repair of the notice boards. Regrettably neither wanted to take on the work. In order to move the project on, Cllr Towns proposed and Cllr Nelson seconded the motion that £500 be set aside for work to be carried out on the two worst notice boards. Work could then be carried out by a contractor that had previously quoted for the work. With no objections the motion was carried.

d) Parish Plan

The Chairman was pleased to advise that the Rural Community Council of Essex (RCCE) were assisting the PC by facilitating the first community meeting to develop the Parish Plan. The meeting was to begin at 10am on Saturday 14 March in the Village Hall. Everyone was welcome to attend.

e) Gardening Express

Regarding the ongoing planning appeal the PC had commented on the proposal to erect a large

building on the site. CCC had advised that the appeal may not be heard until the summer of 2015. Members of the PC had met with the agents of the owner to discuss the development of the site. Members were advised that Consultants would be engaged to assess a number of options. One option would be to move the business to another location. This would rely on raising funds by erecting 5 dwelling houses on the existing site. The owner suggested the plans for the 5 dwellings be presented by consultants at the Parish Plan meeting to be held on 14 March. Members considered the request. It was agreed that it would not be appropriate at this time as the Parish Plan workshop was not the correct forum to consider individual planning applications.

f) Persimmons Homes Planning Application

PC Members attended the CCC planning meeting at which the application was considered. Members put forward representations from the joint statement of common ground presented by CPC, Broomfield PC and Newlands Spring Residents. The Chairman of the Planning Committee applauded the PC for working with other organisations and co-ordinating the joint response; however despite concerns raised, the plans were approved. The Chairman commented that Persimmons Homes might give gift of a strip of land in Hollow Lane to the Chignal Parish Council so as to provide a 'buffer' to further future development. If so the PC would need to consider whether it would want the responsibility.

g) Community Games

Cllr Middleditch reported that an application for £350.00 to provide arena ropes/stakes and Tug of War equipment for the Village Fair had been submitted, regrettably the application had not been successful.

h) Parish Cleansing Days

Cllr Feltwell reported that an application for the CCC to undertake parish cleansing days had been submitted. With regard to the Village litter pick day, the PC had been advised that this year only the coloured litter sacks provided by CCC would be collected, (no black bags). Cllr Feltwell agreed to co-ordinate the collection points.

Chignal Parish Council continued

The meeting noted that CCC had agreed to provide 5 litter picks to the PC on a permanent basis. Members agreed that the PC join the Campaign for Rural England (CPRE) association of litter picks. A source of funding may be available from the ASDA Community Fund.

i) Passing Places

The ECC Highways department had visited, reviewed and developed the proposals for 3 passing places in Chignal Smealy. The new proposal was to place posts at the back edge of the passing places and posts at the ends of 2 of the passing places. The posts could either be permanent or, at extra cost, be removable. A number of concerns had been raised regarding the end posts as a 4 metre width was required for large agricultural vehicles. Further to discussion, it was determined that the posts at the back of each passing place caused no problems. However, so has to accommodate large agricultural vehicles the end posts would need to be removable. Cllr Towns agreed to put the suggestion to the Highways Department.

5. Update – Lafarge Tarmac Landfill Communities Fund

Cllr Towns advised the meeting that the Derbyshire Environmental Trust had approved 100% funding to demolish part of the existing Village Hall and replace it with a substantial building. It was noted that Broomfield Football Club had also benefited from the fund.

6. Public Question Time

- a) In answer to a question regarding the Village Litter Pick, the meeting was advised that, as no skip was available, litter sacks would need to be stacked at collection points. The PC would seek permission of local residents before stacking bags on their property.
- b) A resident questioned why the PC no longer sent a community report to the Essex Chronicle. The Clerk advised that due to time constraints, work had to be prioritised. The meeting was advised that full minutes and representative reports were published in the Quarterly Newsletter which was delivered to each household.

c) With regard to the development in Hollow Lane, a resident reminded the PC of its entitlement to funds from the Community Infrastructure Levy.

7. Chairman's Report

- a) With regard to the forthcoming elections. The Chairman reported that an article asking interested people to nominate themselves can people nominate themselves? was placed in the Chignal News and again asked for those interested in becoming a Parish Council Councillor, to put their names forward to the Clerk.
- 8. County And City Councillors' Reports
 Cllr Nicolette Chambers informed the
 meeting as follows:
- a) Cllr Chambers was delighted to report that the CCC had been shortlisted to receive an organisational award.
- b) The restoration of the Chelmsford Shire Hall had now been completed.
 Consultation regarding what should be housed in the building was on going.
- Consultations regarding the re-design of a new skate park, in Central Park were in progress.
- d) ECC may delegate some of its service responsibilities to CCC. To take the matter forward a joint Cabinet Member meeting was to be arranged for the end of March.

9. Chignal Hall Lane Triangle proposed request to Local Highways Panel

A draft proposal had been previously circulated to Members and residents had been consulted at Coffee Mornings. All agreed the triangle, which was now no more than a lump of mud, was a mess. The Draft proposal was briefly discussed, Cllr Nelson agreed to complete the Highways application form and progress the matter.

The following comments were made.

- 1. The road was very narrow and the access to the property was not immediately apparent.
- Better access may be achieved if the proposed garage building was set further back from the road. No overall objection.

11. Orchard Committee

The minutes of the subcommittee meetings held 11 February were noted.

The meeting was advised that since the last meeting the hedges had been cleared from the fencing and that the trees had been pruned.

- **12. Representatives' Reports –** the Meeting noted the following reports:
- A) Playing Field- Nothing to report at this time.
- B) Village Hall Liaison reported earlier at time 5 above.
- C) Newsletter Including Website Work was ongoing to develop the web.
- D) Gravel Liaison

Cllr Feltwell reported that a retrospective planning application for the restoration of the site had been presented at a meeting held on 6th March. Changes to the original plan included the planting of a wild flower meadow rather than hay and trees be planted, and the area seeded near Pengy Mill. Work on other areas of the site would begin in April; restoration would be complete mid December 2015. The permissive bridle way accessed the highest part of the site and work was in train to ensure that motorcycles could not enter the site. Cllr Nelson agreed to provide information regarding suitable gates and barriers. If the PC had no objections the retrospective planning application could be decided by Planning Officers rather than having to go to a full planning committee. The PC would shortly be receiving a letter regarding the matter. Cllr Nelson and Cllr Feltwell agreed to develop a draft response.

E) Village Watch- Cllr Philpot reported that Gt. Waltham and Pleshey had developed a very successful Parish Watch Scheme.

Chignal Parish Council continued

It was agreed that the matter would be included on the next Parish Council Agenda in May.

- F) Highways -A note of thanks was given to Cllr Philpot for work undertaken on hedges and drainage near to Brittons Hall Farm. It was noted that culverts were blocked near to Stevens Farm.
- G) Footpaths/Bridleways No report at this time.
 H) Telephone Box Chignal St. James- No report at this time. The Clerk noted that there was an outstanding action to organise a Parish Walk to review the state of the rights of way.
- I) Tree Warden A resident had reported a tree near to the 3 Elms Public house which was leaning dangerously. Cllr Aldridge had requested an update from the Highways Department on its removal.

13. Finance

- a) Balances Community Account £3772.80 Savings Account £3,238.10.
- b) Cheques issued since last meeting were noted as follows; EALC social Media course Fee £45.00, Clerks Wages 6 months net £723.70, Inland Revenue £180.80, RCCE Membership £96.00, Chelmsford DBF Newsletter, £84.68.

St Nicholas Church

As the days get warmer and longer this year there seems to be an abundance of blossom and flowers and the birds seem to be singing more sweetly – or is it just me? This spring feels like a real gift.

We have been delighted that since the beginning of the year, when we have had one service on the third Sunday of the month, that they have all been well attended and at Easter there were 19 adults and two children to celebrate together. On Easter Saturday a number of us were at the cathedral for Linda Nelson's confirmation, which was a moving service where the fire was lit to symbolise Jesus being resurrected. In such a small population these are great results. Terry, my husband, said there seems to be something happening there – and he's right.

On Thursday 23 April I was licensed to take on 3 extra churches so I am now not only responsible for The Chignals, Great Waltham and Ford End churches, but also Great and Little Leighs and Little Waltham: 6 wonderful historic buildings at the heart of their communities, even if some of them are not physically at the heart. It is only possible for these churches and communities to thrive if we work together as a team, using our strengths. In the Chignals with Mashbury there has also been a momentous change with Tony stepping down from being church warden, so ably assisted by Helen after some 18 years, 11 of which were without a priest. At the moment there is no church warden, but the different roles of the church warden have been agreed and handed out to the different members of the Parish Church Council. This is a new beginning and we need to find out what it will mean. So many of you have stepped up to the plate and are helping in so many different ways. An example was the great church yard clear up – where bride and bridegroom along with family and friends supported a team of other locals chopping back and getting rid of ivy etc. I should point out that the bridegroom and bride in question are from different weddings and are not marrying each other!

We are very excited by the 2 fundraising concerts on Sunday 14 June at 5 pm and 7.30 pm where the international soprano Verica Grmusa will be entertaining us. The tickets at £15 are a real snip – she is also singing in Cambridge, where I'm sure the tickets are much more expensive and this is one not to be missed. The money raised will be for the work of the church in this community.
