Business dealt with by clerk during November

### ITEM 1

#### CO-OPTED COUNCILLOR

Councillor David Urie was unanimously adopted as a councillor to serve on Chipping Parish Council.

Declaration of acceptance and member pecuniary disclosure forms were filled in and signed by Cllr. Urie and witnessed by me and signed by me , Barbara Green Clerk. A copy of the Parish council Code of Conduct was read and given to Cllr. Urie.

The forms have since been handed in to the legal department , Ribble Valley Borough Council. Copies have been kept by the Clerk C.P.C.

### ITEM 2

8.11.20. Cllr. Urie and the Clerk attended the Chipping War Memorial to lay a wreath to honour the dead , on behalf of the Village.

About 100 people also attended , all spread out .Mr Gareth Mitchel read out the poem at the going down of the Sun and led the congregation to say the Lords Prayer .Cllr. Urie had some spare wreathes from the British Legion which were given to the public to place on the war Memorial.

I have since received 2 telephone calls thanking Cllr. Urie and Mr. Mitchel for marking the event in this very small , for Chipping , way.

### ITEM 3

E=MAIL from Village Hall asking if the parish council would buy 2 light bulbs for the Sate Park..cost £80 each.The Parish Council holds £350.00

Raised by the skatepark committee and banked 2 years ago.On making enquiries I have been told there no longer is a committee so I considered the cost of repairing the lights should be taken from the £350 held by the Parish Council.

I checked all the green lights showed on the defibs and reported back to the schools.

I offered on behalf of the parish council to refund any cost incurred by the first responders, but was told at the moment they had plenty of funds, received from generous donors. I thanked Barbara and Martin .

Ribble Valley have agreed a grant of £500 for Christmas decoration , to be paid on receipt of paid invoices.
