Item 1

B4RN

The project extending the number of connections to B4RN broadband is proceeding nicely, 320 connections. A line needs to be dug around the side of village green.

Damage caused by farmers digging in to the B4RN cable was quickly repaired.

Item 2

Environmental Energy Project

Councillor Hunt reported a grant of £40,000 has been secured to carry out a feasibility study. Avico will do the study in conjunction with Chipping community land trust, Renewable energy. Estimate it will take twelve weeks, to involve the community to include a public meeting in the village hall, Covid permitting.

Item 3

Playing Field / Muga

The Councillors are liaising with the football club and others to establish a working relationship with users of the Chipping Facilities to establish a way forward regarding use and maintenance of the Field Muga and skatepark.

The clerk is pursuing the insurance claim with Zurich regarding damage to skatepark.

Item 4

Playground

Cl. Urie continues to supervise and maintain the playground.

Councillors decided a key safe to be bought and positioned to allow R.V.B.C. grass cutting team to access the area.

Also contrasting coloured paint to be bought and painted on to the exit gates on the playground to highlight them. Equipment on the playground has been given a good clean by councillors.

The Chairman showed large visual plans of the proposed future ideas for the playground refurbishment. To be paid for from 106 grant from the Fellside development.

The Chairman to review the options with the supplier .
