Item 1

Playing Field /Muga

Muga lights inspected,in discussions with electricians.

Councillors have chosen to give the job of repairing the lights to Cronshaw Electricians. The cost has risen by £1200. It was decided that Cronshaws was the best company for this job.

Financed sourced

R.V.B.C GRANT £2000

DONATIONS FROM FOOTBALL CLUB £3000 AND VILLAGE HALL £13500.

Work to be done in September

Old trees cleared from various areas around field stumps to be treated by a tree surgeon to prevent regrowth.

Price agreed with tree surgeon £550.

Lines to be painted on MUGA to facilitate netball to be played as well as football.

Document to be drawn up by Parish Council regarding hire of MUGA.

The skate park damaged wall has been repaired.

The insurance company Zurich, have agreed to include wall as part of the skate park asset included in the £46,000 insurance cover.

Skate park lights to be inspected and repaired.

The insurers do not insure for wear and tear on carpark surface.

Accidents, covered by councils public liability insurance.

“Parking at owners risk” signs to be bought and placed on carpark.

The advertising signs on the side of the football pitch and the viability of movable signs for match days, using existing boards was discussed, as a way forward until a public consultation can take place.

Fund raising on the field 4.7.21. for CRY. Event to start 11am. Councillors will attend.

Item 2

Playground

The 106 grant for the playground is nearing availability date. Extra finance to be sourced possibly in two staged grants.

Councillors have discussed the idea of preparing the playground area using local skilled volunteers to help keep the costs down.

Councillors all agreed this is a good viable very doable idea.

An A frame climbing frame on the play area is rotting . It has been repaired
councillors decided the piece of equipment should be removed .

The exit gates on the playground have been painted in highlight paint on the
inside as a legal safety requirement.

Permission has been given by the Parish Council for a way lease across the
Village Green.
