Open Forum

Members of the public were present to discuss
advertising boards on the perimeter of the
football pitch.

The debate was opened with the point that
income derived from the advertising was needed
to supplement fund raising deficiencies due to
Corvid restrictions.

The football club regularly raises money from
a variety of events and donates to the
Parish Council to pay for the expensive
drainage maintenance treatments, needed to
keep the playing surface of the field, which is
owned by the Parish Council, playable.

As well as the donations to the Parish Council, the football club supports approx. 130 young boys and girls to play football, by keeping membership fees very low and supplying all the kit to the children, including coats.

Adult members as well as fund raising play in the older age groups teams, coach the younger players and help maintain the area.

Members of the public, ^{present} did not agree with permanent perimeter boards on the field as it was thought inappropriate in this rural village bordering a conservation area.

The football playing season extends for nine months of the year, with the majority of matches played Saturday and Sunday. Training takes place during the week at various times during the season.

The possibilities of movable advertising boards was discussed. This would be very time consuming needing a lot of man power before and after games.

A compromise may be the answer with the boards allowed to remain in situ during the weekend.

Councillors allowed for a planning application for perimeter advertising boards to be sent to R.V.B.C. for their consideration
