14 PROPERTIES HAVE BEEN HIGHLIGHTED AS SUITABLE FOR THE BORE HOLE GROUND SOURCE SCHEME. CHEAPER ELECTRICITY CONTINUES TO BE WORKED OUT .IDEAS INCLUDE A SHARE SCHEME ---SOLAR PANELS GENERATING ELECTRICITY TO SERVICE THE VILLAGE NOT THE NATIONAL GRID. RESIDENTS WOULD PAY A STANDING CHARGE.

KOMPAN AGREED TO CHANGE BOAT SWING AND ANCHOR ATTACHMENT CHAIN TO STOP THEM TWISTING AND BREAKING IN THE FUTURE. THE COST OF £1000 TO BE COVERED BY KOMPAN. THE WET PORE IS TO BE REPLACED AT NO COST TO THE PARISH COUNCIL.

THE FOOTBALL CLUB HAS ASKED THE PARISH COUNCIL FOR PERMISSION TO APPLY FOR GRANT/PLANNING

PERMISSION, TO ERECT POLES AND NETS ON SIDE OF PITCH, TO PREVENT BALLS GOING ONTO NEIGHBOURING

PROPERTIES AND ROADS

COUNCILLORS AGREED CLERK TO LIAISE WITH RESIDENTS.

THE VILLAGE HALL COMMITTEE AND THE FOOTBALL CLUB ARE NEARING AGREEMENT REGARDING THE MANAGEMENT OF THE MUGA. THE FOOTBALL CLUB WILL LOOK AFTER THE PITCH, PAY NO HIRE FEES, PAY FOR ELECTRICITY AND MAINTENANCE. THEY MUST ALSO ACCOMMODATE OTHER GROUPS TO HIRE THE PITCH WHEN IT IS AVAILABLE. A THREE WAY AGREEMENT TO LAST FOR TEN YEARS TO BE DRAWN UP BETWEEN THE VILLAGE HALL COMMITTEE, THE FOOTBALL CLUB AND THE PARISH COUNCIL AS OWNERS ON BEHALF OF THE COMMUNITY.
