The public nuisance calls are in keeping with previous months and, and was mainly weekend revellers returning home at weekends, along with associated drunkeness.

#### **Summary of Calls and Crimefiles compared to last month:**

#### AS3A - Ferryhill

- Quality of life calls have decreased by 5
- There were 0 Housebreakings
- Vandalisms have decreased by 1
- Thefts of or from vehicles have remained the same
- Overall CrimeFile offences have reduced by 2

#### AS3B - Mannofield

- Quality of life calls have remained the same
- There was 1 Housebreaking
- Vandalisms have decreased by 1
- Thefts of or from vehicles have remained the same
- Overall CrimeFile offences have decreased by 1

#### AS3C - West End

- Quality of life calls have decreased by 2
- There was 1 Housebreaking
- Vandalisms have decreased by 5
- Thefts of or from vehicles decreased by 9
- Overall CrimeFile offences have reduced by 18

#### **GENERAL INFORMATION**

Once more this month we have seen a reduction in the number of thefts of and from vehicles across the area.

We generated a lot of publicity over the last few months about the need to take basic security precautions such as locking doors etc, and it is possible that this message, combined with the enforcement action taken by my Operation Drina team in October has assisted in this reduction.

It is still vitally important that members of the public continue to secure their homes, cars and garages routinely and think about basic things like light timers for their homes when they are out in the hours of darkness.

I have included some festive crime prevention advice alongside this document for circulation as you see fit.

On a personal note, as the last Performance Document for 2015 is completed, I'd just like to thank you all for your support over the last year, and look forward to continuing our strong relationship into 2016.

I'd also like to welcome the members of the recently formed Braeside and Mannofield Community Council and look forward to meeting with them in due course.

These e-mail addresses are not for reporting crimes or offences. The process for reporting any crimes or offences is to call 101 (Aberdeen Service Centre) who will log the call on our Command and Control system and allocate the incident to our area. Using this process negates the possibility of the report being missed and also ensures that the callers detail, addresses and telephone numbers are noted for our awareness and response.

Your comments and concerns are important to the staff of the West End CPT. This allows us to allocate our resources to the areas causing you the most concern.
