Quality of Life Calls

There is a reduction of 5 incidents compared to last month.

There is a reduction of 9 Public Nuisance calls, albeit, these calls were predominantly youths causing annoyance and City Centre revellers heading home.

Of the 5 Fire calls 4 were non-suspicious and no-one was injured, the other was a bin set on fire, this enquiry is now complete and no one has been identified as responsible.

4 Persons have been reported to the Procurator Fiscal in relation to the Drugs Offences.

The main reduction compared to last month is 29 Vandalisms, 3 Drugs Offences and 3 Thefts from vehicles.

The two break-ins (Theft by OLP) to cars at Palmerston Road are connected and occurred at the same time. This enquiry is complete and the person responsible has not been identified.

- There were no Housebreakings
- Vandalisms have reduced by 12
- Thefts of or from vehicles have increased by 2
- Overall CrimeFile offences have reduced by 11

GENERAL INFORMATION AND UPDATE ON PREVIOUS QUERIES

Update re Road Traffic Operation on 15 and 16 December 2014 - 4 Officers from the Whinhill Police Office with the assistance of our Roads Policing Unit, Special Constables and City Wardens, patrolled the streets throughout the Westend CPT in an effort to target areas where instances of anti-social driving, speeding, inappropriate parking and other offences had been reported to the Police by residents, schools, Community Councils and elected members.

As a result of this Operation 16 drivers were cautioned and charged regarding various Road Traffic Offences including Speeding, Careless Driving, failing to obey Red Traffic Lights, failing to obey Directional Road Signs, using a Mobile Telephone whilst driving and failing to wear a Seat Belt. 10 drivers were warned regarding Speeding. 49 drivers were educated regarding their driving behaviour and speeding. 6 others were educated regarding minor Road Traffic Offences.

At various times and locations our Officers were approached by residents who were all receptive to our actions and most commented that they were very pleased with what they were witnessing.

We met our objective by attending and addressing issues reported by our local residents, schools, Community Councils and councillors. This was a well worth exercise and will hopefully be repeated throughout 2015.

Our team at Whinhill are committed to keeping the community safe, preventing and detecting crime. If any suspicious activity is seen, please report this to us, either as an emergency on 999 or to the Service Centre on 101. Quick and effective reporting allows our team to react accordingly and maximise the opportunity to apprehend offenders.
