The number of quality of life calls has again fallen this month.

The drugs/substance misuse calls are a mix of calls with information, and Officers having stopped people with drugs on their person.

There was one instance of fireraising, relating to a small pile of rubbish being set on fire on Market Street.

The public nuisance calls fell slightly, but is in keeping with previous months and, and again were a mix of incidents ranging from revellers returning home at weekends, to youths being noisy.

Crime has fallen substantially over the last month, most noticeably in relation to thefts from vehicles. Some of this will be due to the impact of Operation Drina which ran during September and October which focused on this type of crime, though we will not be complacent, and continue to patrol susceptible areas.

**Streets with more than one crime are as follows:**

The possession of drugs offences were found by Officers and dealt with at the time.

The Holburn Street vandalisms are minor in nature and differing locations and times, and so are not related.

The Portland Street incidents occurred on the same night (27th) and at the same locus. Two vehicles had windows smashed and the contents rummaged, but nothing stolen.

The St Johns Terrace incidents occurred three weeks apart and do not appear related - one was a car and one was a motorbike. The car had possibly been left insecure with keys within.

The Union Grove incidents occurred on the same night and relate to the wing mirror glass being stolen from two similar vehicles.

**Summary of Calls and Crimefiles compared to last month:**

**AS3A – Ferryhill**

- Quality of life calls have decreased by 5
- There were 0 Housebreakings
- Vandalisms have decreased by 1
- Thefts of or from vehicles have remained the same
- Overall CrimeFile offences have reduced by 2

**AS3B – Mannofield**

- Quality of life calls have remained the same
- There was 1 Housebreaking
- Vandalisms have decreased by 1
- Thefts of or from vehicles have remained the same
- Overall CrimeFile offences have decreased by 1

**AS3C – West End**

- Quality of life calls have decreased by 2
- There was 1 Housebreaking
- Vandalisms have decreased by 5
- Thefts of or from vehicles decreased by 9
- Overall CrimeFile offences have reduced by 18

**GENERAL INFORMATION**

As stated earlier in the document, some clear reductions in vehicle related crimes this month, which was to be expected given the high profile media presence that Operation Drina attained in September and October.

We won't be complacent however and we will continue to use everything at our disposal to target areas we see as being at risk of crime.

Over the next few weeks we will be focusing on supporting the national "Lights out - you're out" crime prevention campaign, which means we will be putting security advice leaflets through doors of dark properties when carrying out our routine duties.

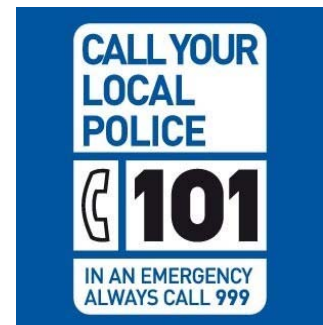
