## **B&NES Support Proposal for the VCS**

Jilly Edwards gave the background of the recent proposals for sector support. St John's had agreed to contribute £30,000 but it has to be match funded and now the Local Authority have no additional money available due to further cuts from Central Government.

Some work had been done previously on identifying the type of support the sector needed. It was thought that the previous VCS Forum was covered by St John's Breakfast Meetings (this was challenged later in the meeting – although the breakfast meetings are great and good for Networking they are not informational on strategic issues nor is there any mechanism to canvas opinion and feed collectively into local strategy)

Other support needed was identified as support for small organisations just starting out and someone with a co-ordinating role for the VCS.

Local Giving are keen to set up a project in B&NES, working with 70 organisations, training them in efficient use of the Local Giving Platform and developing an online fundraising strategy with the premise that each organisation signing up will raise

£1000 over the year. Funding required to start this project is £80,000. St John's have agreed to contribute half. It may be similar to that proposed here: https://www.salfordcvs.co.uk/job/local-giving-development-manager-manchester

Members challenged whether this support would be anything more than promoting their own platform and whether it would be the best use of the potential £40,000 available from St John's for support for the sector.

Members discussed that what we needed was someone at a senior level to represent the interests of the VCS. Last year we had made some progress into identifying a cabinet Member for the VCS but this all changed with the new administration.

#### Other initiatives:

- The Care Forum have put in a European Funding bid for money to set up a Volunteer Support and Progression Hub aimed at supporting the more vulnerable into volunteering.
- Mike Plows at the Volunteer Centre has been funded by St John's and
  Quartet to prepare a database of VCS organisations in B&NES. It should be
  going live this week (w/c 22 Feb) so we are waiting to hear when we can
  submit our information for inclusion.
- There is potential funding for Social Enterprise from Great Western Regional capital (Members commented that many organisations were not ready to consider the Social Enterprise model).
- Child Poverty Initiative this is headed by St John's and Ben Howlett (MP for Bath) and is looking to halve child poverty in the area by 2020. St John's has agreed to contribute £100,000 and are looking to raise more by a local campaign to a total £250,000 but money will only be available for organisations that are in collaboration. (Members agreed that the publicity for the VCS work in the area would be good but the local campaign would otherwise just distribute the goodwill of the local population differently making funding harder to achieve if not in collaboration with other charities.)
  Collaboration is a detailed and time intensive process which not all organisations will have the capacity to engage with.

Members present considered what were the sectors most pressing support needs – apart from funds:

- Good communication avenues with B&NES who is the right person to talk to, what is going on.
- Someone at high level to represent our interests as sector.

We discussed what support and avenues of communication were available at the moment.

- THRIVE a training and support programme for the cultural and voluntary sectors in B&NES, funded by the Local Authority and managed and delivered by Mackeral Sky. <u>More information here.</u> (Only two members present had heard of them and they tend to deliver more to the cultural sector.)

Members discussed Connecting Capacity who had a previous commission to work in B&NES and THRIVE who hardly anyone knew was working in B&NES and discussed the fact that significant amounts of money were being spent supporting the sector without us benefitting so who was supposed to ensure commissions addressed sector need. Members decided it would be useful to have a breakdown of what had been commissioned and what funding had been allocated over the last 3 years.

Members discussed the fact that, if the St John's £40,000 was available it might be worth us looking at putting in some money ourselves for proper support. An amount in line with each organisations funds but that this would then be independent of B&NES. There was support for this idea but some members felt they already had to pay to national bodies out of limited resources and this would be another potential drain on funds. Also, to be of any real value the support would need to be ongoing over at least 3 years, so where would the continued funding come from? It was suggested that B&NES ought to put up some funding too as they are expecting the sector to take on a lot of the work they no longer have funds for and, at the same time, are imposing a lot of additional red tape.

Where do we go with this next?

Julie is employed by Business in the Community and Seconded from the Civil Service for one year. She has a background mentoring and supporting young people, a volunteer guide leader for 20 years, has done a lot of charity fundraising and is a charity trustee.

## 14 – 25 Draft Strategy

No one was available to come and update us on this but we looked at the draft strategy with a view to feeding comments to the next stage of its' development. Here is a link to the draft strategy document.

Members did not think the strapline adopted Employment is Everybody's Business' matched what our aspirations for our young people should be.

It was agreed that this strapline made a bit more sense in terms of the strategy being aimed at SEND young people and aiding their access to employment but, even then there should be a broader interpretation of hopes for these young people than just to get jobs.

It was agreed that some young people would be unlikely to gain employment because of levels of complex need. Also some young people may elect to be full time parents. There should be some acknowledgement of different types of aspiration.

There was no mention of mental health and wellbeing in the document.

The developed strategy needs to reflect the realities of life generally for 14-25 year olds not just link in to strategy and objectives determined nationally.

There was no mention of negatives i.e prevention measures against drug abuse, teenage pregnancy, etc.
