# **National News and Information**

**Canada's Caring Dads programme in the UK.** Caring Dads is at the forefront of work with abusive fathers in North America and around the world. The NSPCC's **impact and evidence insights** blog features an article by Dr. Katreena Scott on creating and developing Canada's **Caring Dads** programme. Issues discussed include: the inception and development of the programme; bringing the programme to the UK with the NSPCC; standardising the programme. Read more here.

**Coping with Crying Programme,** a short film which aims to show parents coping strategies they can use with a crying baby and explain the dangers of roughly handling an infant. Key findings include: evidence suggests that during times of stress parents who had watched the film were reacting in a positive way to their infant crying and were seeking help when it was necessary. **CSE - Alice's Diary.** Hampshire Constabulary has launched a campaign to help people identify the signs of child sexual exploitation. This includes a blog written by 15-year-old 'Alice', her friends, family and teachers about how CSE happened to her. #### Sporting Future: A New Strategy for an Active Nation

Sport England has published its <u>strategy</u> to support the delivery of the government's <u>Sporting</u> <u>Future: A New Strategy for an Active Nation</u>. The strategy outlines Sport England's plans to invest more in children and young people as well as working with a wider range of partners and encouraging innovative delivery. The <u>Sport and Recreation Alliance</u> identified potential opportunities organisations should consider, including: the focus on inactive cohorts; the ability to broker partnerships across sectors; evidencing your ability to work with over 5s and how to utilise and develop your volunteer workforce

**Infant mental health**. The NSPCC is putting a spotlight on the importance of looking after the mental health needs of babies and young children in care. They have published a case for change which brings together a wide range of research and practice evidence which tells a compelling story about why we need to rethink our approach to infant mental health in the care system. **Further information**: Looking after infant mental health: our case for change .

**Evidence sharing**. The Guardian has published an article about the importance of evidence sharing in the voluntary sector. The article uses the example of a partnership between the New Philanthropy Capital (NPC), the NSPCC and Hactar to outline benefits of sharing information, including: learning about what works, saving costs by preventing organisations from making the same mistakes and increasing impact by working together. <u>Read the article here.</u>

**Children and Social Work Bill**. Part one of <u>Children and Social Work Bill</u> focuses on children in care and care leavers, proposing a covenant to publish services to which care leavers will be entitled, including the right to access a personal advisor extended until 25 which will support care leavers to transition to adulthood. Clause 15 empowers local authorities to seek 'power to innovate' freeing up frontline services to collaborate creatively to provide more effective care to safeguard children and young people. **Children England has published a first analysis of the Children and Social Work Bill 2016** This looks at the provisions of the Bill as they relate to the demands of England's Children: <u>Children and Social Work Bill 2016</u>: how does it address the demands of England's Children: a manifesto?

**30 years of ChildLine**. The Guardian (7 June) featured an article on the development of ChildLine since it began 30 years ago. Issues discussed include: the predominant concerns being raised by children are now family relationships, low self-esteem and unhappiness; most ChildLine counselling sessions now take place online; the importance of an understanding voice at the end of a telephone has not changed. <u>https://www.theguardian.com/society/2016/jun/07/30-years-childline-children-friendly-ear-online</u>

**Stone King Briefing: The PSC Register** - An introductory guide for charities. Since 6th April 2016, there has been a legal requirement to put in place a Persons of Significant Control ("PSC") Register. <u>Stone King has produced a briefing note</u> on the key aspects of the new requirements **The requirement affects your organisation if you:** 

- operate as a company;
- have a corporate trustee company; and/or
- have a trading subsidiary company.

From **30th June 2016**, this information needs to be filed with Companies House on incorporation and updated when you submit later 'confirmation statements'. If you were incorporated before 30th June 2016, you will need to provide this information in your first confirmation statement.

**New Guidance for Charity Fundraising.** This guidance explains what trustees need to do to comply with the law relating to the management and control of their fundraising.

The guide sets out 6 principles the trustees should follow to achieve this and also includes a checklist for trustees to evaluate their charity's performance against the legal requirements and good practice recommendations set out in the guidance.

**UN slams government's record on children's rights.** The United Nations Committee on the Rights of the Child has highlighted a raft of "serious concerns" about the government's treatment of vulnerable and disadvantaged children. Concluding remarks, made in the committee's fifth report on the UK's compliance with the UN Convention on the Rights of the Child (UNCRC), are particularly critical of the effect that the Conservative government's austerity measures have had on children from poorer families. <u>Read more here.</u>

'Every Victim Matters': SARI extends its reach into B&NES through partnership working Stand Against Racism & Inequality (SARI) has just secured a new 5 year grant from the Big Lottery Fund to extend its reach in tackling hate crime. A new project called 'Every Victim Matters' will be run in partnership with a group of organisations including The Diversity Trust, Taunton CAB, Compass Disability and Brandon Trust and will see SARI's Bristol-based work to extend to Bath and North East Somerset, North Somerset and Somerset.

The service aims to improve the safety, quality of life and confidence of victims through specialist help and advice, tailored to the personal experiences and needs of each individual. Trained caseworkers are able to offer both practical and emotional support to those affected all kinds of hate crime, including age-based, disablist, faith-based, gender-based, homophobic, racist or transphobic. Some of the grant will be allocated towards providing training for over 750 professionals who will work towards increasing knowledge and awareness of hate crime among statutory bodies, community groups and agencies. There will also be funding for group sessions to build confidence and resilience in those at risk of or affected by hate crime. <u>Click here</u> for the full story.

**Comic Relief launches new core funding for small organisations** Comic Relief has recently launched its new strategy. The approach to funding will be a mix of rolling programmes and targeted one-off programmes. In implementing its strategy, Comic Relief will be testing out some of these approaches. The latest one to be piloted is the Core Strength Funding Programme, which opened on the 16th June with a deadline for applications of the 27th July. The criteria is as follows:

Support to small organisations delivering work in the UK with an annual income of between £100,000 - £500,000, across any one of our four programme areas (as outlined in our new grants strategy) which are:

- Investing in children and young people to be ready for the future
- Empowering women and girls to be free to lead the lives they choose
- Improving the health and wellbeing of vulnerable and disadvantaged people

• Building stronger communities in areas of disadvantage, deprivation and poverty Applications from organisations who play a vital role in their locality in the UK and can demonstrate how this funding will help strengthen their organisation. CR will also explore what support in addition to the grant itself is useful for strengthening the organisations we fund – this might include help with media and communications or sharing expertise. Grants will be up to £20,000 for each of two years (maximum grant of £40,000). We anticipate that we'll make approximately 100 grants initially, to a total value of £4 million.
